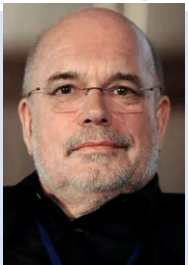

“I attended a Multistakeholder Dialogue initiated by the German Ministry for Digital and Traffic and the IGF Germany in Berlin.

This time, the [Global Digital Compact](#) (GDC) was the main topic. The ministry gathered input from other stakeholders on how best to represent everyone’s interest during the discussions related to the GDC.

There was broad agreement that the multistakeholder model and the IGF needs to be continued and strengthened and that increased government control could mean the end of a global, free and open Internet.”

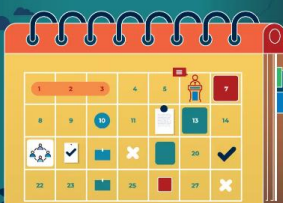
