# ICANN Middle East Engagement Strategy (2013-2016)

In December 2012, ICANN called for the creation of a working group to develop an engagement strategy for the Middle East, and invited ICANN community and constituency members to join this effort.

22 people from various sectors and 11 countries in the region participated. Working together the group formulated a strategy focusing on the needs and priorities of the region within the scope of ICANN's role. To achieve the goals of the program 3 strategic focus areas were defined by the working group: DNS Security and Stability, Domain Name Industry, and the Internet Governance Ecosystem.

## Goal 1



Build a strong and competitive domain name industry in the region.

## Goal 2



Promote multistakeholder Internet governance mechanisms in the region.

## Goal 3



Foster two-way engagement between ICANN and the broader Internet community in the region.

## DNS Entrepreneurship Center



DNS-EC is a joint project between the ICANN & the National Telecommunication Regulatory Authority of Egypt (NTRA).

The Center provides training workshops, material and mentoring programs.

## DNS Market Study



Published in February 2016 the study analyzes the state of play of the DNS Industry in the region within the context of the broader global ecosystem.

The study provides benchmarks and recommendations with a view to improve and grow the DNS Industry regionally.

## New Partnerships



Memorandum of Understanding with the NTRA in Egypt to launch the DNS - EC in Cairo, Egypt

Memorandum of Understanding with the CRA in Qatar to explore synergies on how to promote ICANN's work

Memorandum of Understanding with EURid to develop local expertise in DNS technical, policy, and business areas in Africa and the Middle East

Launched in 2013

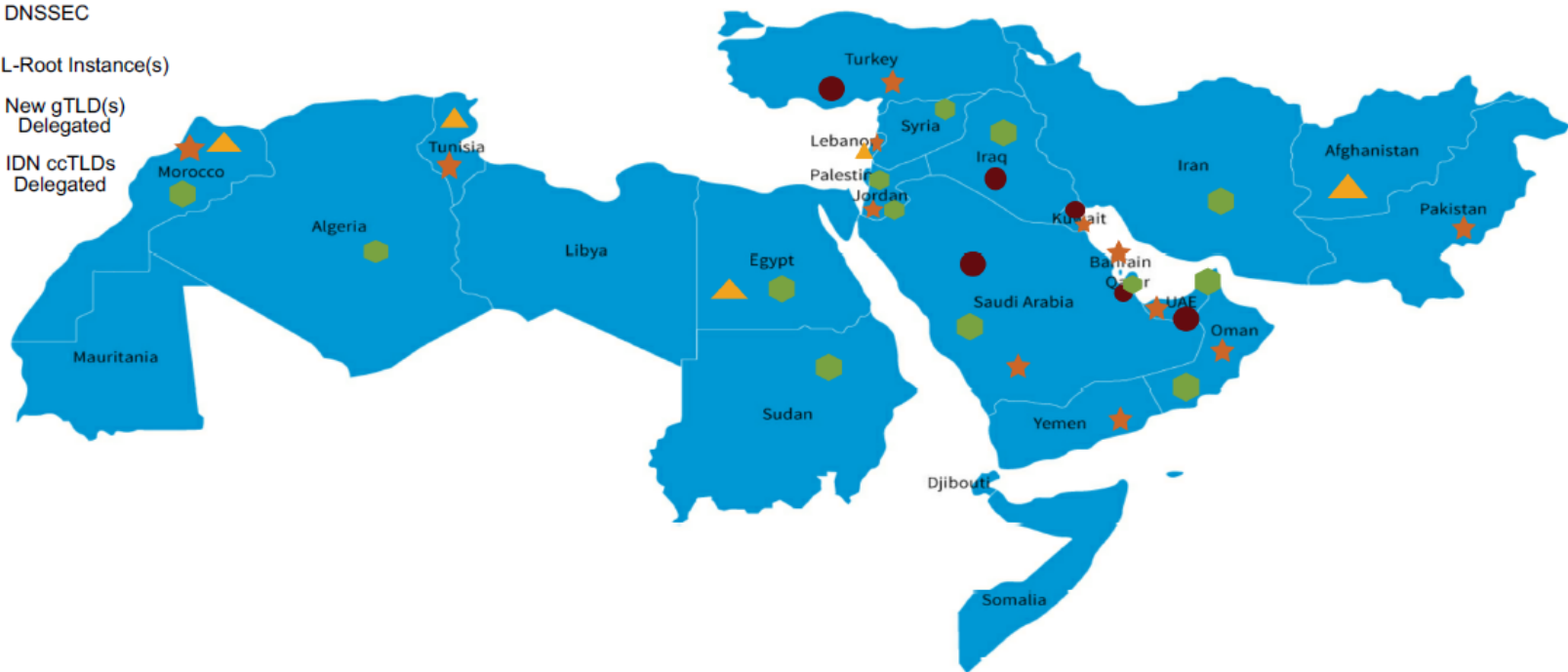

### L-Root Deployment

10 instances of L-Root had been deployed regionally in 2013; by 2016 this number had increased to 20. The most recent deployments taking place in May 2016 in Islamabad, Pakistan and Lahore, Pakistan.



### IDN ccTLD Delegations

In 2013 10 IDN ccTLDs had been delegated. In 2016 the number had reached 13 with the addition of Iran (ایران), Sudan (سودان), and Iraq (عراق).



### DNSSEC Deployment

Prior to 2013 DNSSEC had been deployed for 1 ccTLD - Lebanon (.lb). There have been 4 subsequent deployments.

## Government Participation

In 2013 17 countries from the region were members of the GAC. In 2016 the number had reached 20 with the addition of Mauritania, Palestine, and Sudan.

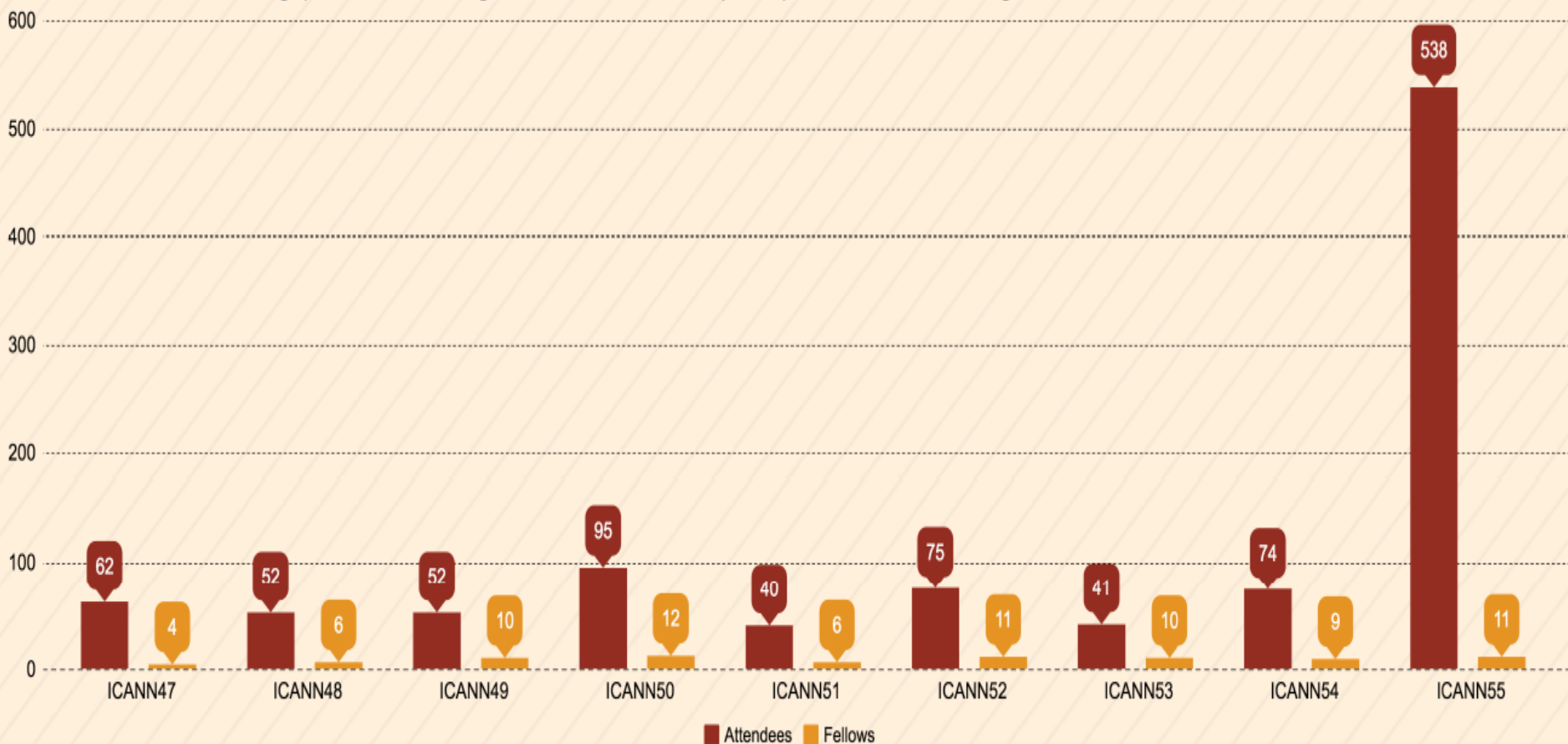
ICANN meeting attendees from the region since ICANN47 total more than 1,100.

Within the sponsored workshops, forums, and trainings offered, 92% of attendees were newcomers, with 4% of newcomers going on to become active participants at ICANN.

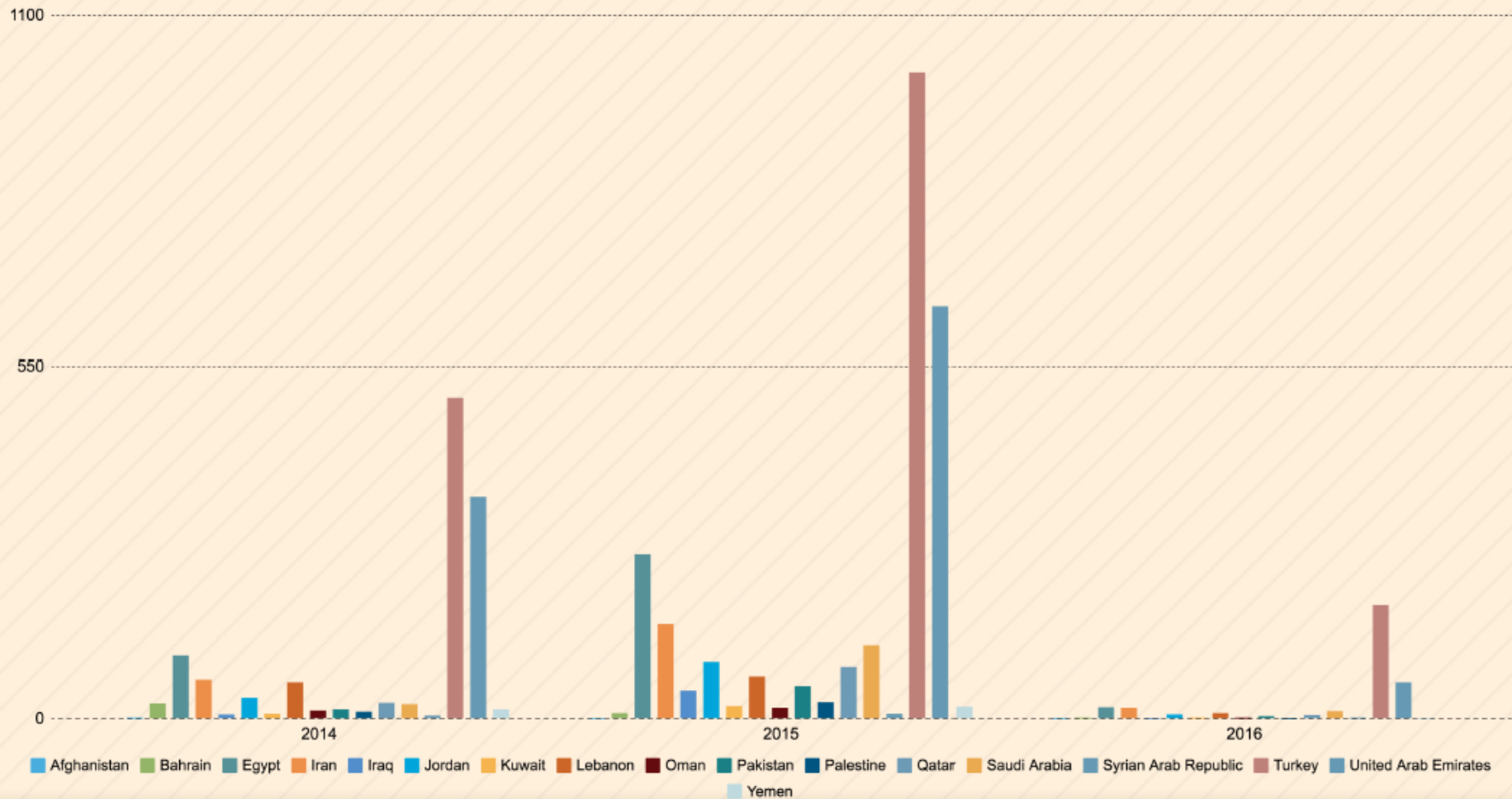
# Attendance at ICANN Meetings
