Anticipated Activities

An Approval Action Community Forum has been scheduled during the ICANN 66 meeting in Montréal, Canada between 08.30h — 09.30h local time on Sunday, 3 November 2019.

In accordance with Annex D, Section 1.3(5) of the Bylaws, this Forum will be managed and moderated by the Empowered Community Administration.

Logistical and Forum format and content issues are being discussed between ICANN Staff, and the Empowered Community Administration. These discussions are ongoing. The Empowered Community Administration expects that at least one representative from the ccNSO Council will be present at the forum to the explain to the Community the rationale behind the Fundamental Bylaw change.

Empowered Community Administration Issues

As we are approaching the third-year anniversary of the transition of ICANN/IANA from NTIA oversight, it is evident that there are still some serious outstanding issues regarding the relationship between the Empowered Community Administration, ICANN org, and ICANN legal. They are, in my view resolvable with better sustained and regular communication. There is recognition amongst all parties for this, and we will be meeting in Montréal to both do a "reset" and seek a better path forward.

I would also like to note that the Empowered Community Administration members need to do a better job of communicating with each other. This is also something I hope we can achieve at the Montréal meeting.
