Javier Rua-Jovet (ALAC co-lead):@Farzaneh remember you can agree or disagree with all of these preliminary recs. in your comments. But remember these are consistent with 2012 Applicant Guidebook.

Farzaneh Badii:implementation of 2012 guidebook is not a justification! continuing bad practice you saw what happened. Did all the governments apply for those "reserved" names? No

Martin Sutton (WT5 Co-Lead):@Farzaneh - deliberations contained within the report will reveal a mix of opinions (e.g. reserve more, reserve less), so it is worthwhile reading through the different opinions that were considered before reaching the preliminary recommendations.
