I have more than 35 years of experience in the IT industry including hands-on engineering experience focused on improving internal processes for clients and, for 15 years, leading large teams of engineers in similar tasks. As a 19-year Verisign employee, I have been responsible for performance measurement and process improvements for our global registry systems for both resolution and registration services. During the past eight years, I have been a member of Executive Leadership Team with direct management responsibility for the platforms that provide our root, .com and .net services to customers. As a publicly traded company, I am responsible for ensuring our public disclosures are accurate and complete within my areas of responsibility and I work within systems designed to ensure proper controls over financial reporting and proper disclosure controls. I have routinely briefed our Board of Directors in my areas of responsibility and I serve as a board member for our subsidiary in China. I actively participate in our enterprise risk process, which uses the COSO framework and my teams help support the Company ' s implementation of NIST controls for cybersecurity. Specifically as to ICANN, my teams were deeply involved in the IANA transition and the bottom-up work on accountability, which I oversaw under my responsibilities within the Company for policy management and engagement with ICANN and the community. Having worked in the ICANN community for almost two decades, I have an important and informed perspective about the obligations, challenges, expectations and risks associated with ICANN org.

While possessing strong opinions, given my experience, I also see the need for compromise to achieve consensus and have demonstrated the ability to seek solutions that are appropriate for our industry. I believe in the multistakeholder model of Internet Governance, but to succeed it requires compromise, patience, and a willingness to learn. It also requires engagement and time commitment, which I have demonstrated and will do so as a member of the ATRT3. As an engineer serving customers and leading the teams that design the functions and features for Verisigns systems that serve registrars, registrants and the all Internet end-users I have a commitment to learning from them as well as my staff to achieve success. I believe that the success in my career has been built upon leadership, listening and the development of strong personal relationships.

My leadership at Verisign supports my participation in this review team and I will ensure that I am available to complete the review.
