When we were doing the earlier set of supplemental procedures, we had some back and forth between ICANN and Sidley, while keeping Becky in chain, so this could be handled similarly.

I've removed a lot of the track changes from the areas that are not under question. Where I had comment or proposed modification, you'll see an "SE NOTE" or green highlight.

There is a lot of good material to work with here, but I think that there are a few areas where the procedures could benefit from some more specificity.
