Berry Cobb: (11:43) I see what you've done in the proposed workbook is to document that there are role changes as we step through the processing activity from collection to transfer.

Marc Anderson (RySG): (11:48) same with IP address in this scenario - it may be personal data, but we (registries/registrars) need it in order to activate the domain name.

Marc Anderson (RySG): (11:49) and it needs to be published in the DNS

Alex Deacon - IPC: (11:50) Would it be applicable when purpose 7 is in play?

Marc Anderson (RySG): (11:51) we tried to avoid mixing purpose 7 (additional elligibility requirements) with this purpose.

Marc Anderson (RySG): (11:56) clear to me Alan (for what it's worth)

Sarah Wyld (RrSG Alt): (11:56) I dont think Registrar needs to retain data beyond the liftetime of the domain, to fulfil this purpose

Kurt: (11:58) The life of the domain = until deletion (correct?); as opposed to expiration, etc

Marc Anderson (RySG): (11:58) as in optional to provide (by the registrant) required to support by the registry

Kurt: (11:59) And registrars might retain data for business purposes but that is not an ICANN purpose so needn't be here, correct?

Trang Nguyen (ICANN Org Liaison): (12:05) @All, ICANN org has not had an opportunity to review this. We previously flagged some issues/concerns with the designation of joint controller and that the responsibilities require further discussion. Dan is listening, but not in a position to speak so we'll review and revert with any comments/questions.

Alex Deacon - IPC: (12:06) OK - I got it. thanks.

Sarah Wyld (RrSG Alt): (12:06) Thanks Marc for this explanation

Alan Woods (RYSG): (12:07) yes thank you Marc

Alex Deacon - IPC: (12:08) so the IP is only optional for out of zone nameserver IP's, but required for in zone nameserver IPs.

Alex Deacon - IPC: (12:09) as it pertains to A-PA4

Marc Anderson (RySG): (12:10) well, it's always optional to provide... you can allocate without activating.

Marc Anderson (RySG): (12:10) the purpose of that text is really to note that in some cases, the registry must process IP address (for performance of the contract)

Alex Deacon - IPC: (12:10) ok

Sarah Wyld (RrSG Alt): (12:13) Can we possibly understand the lawfulness of processing without defining the responsible parties?

Stephanie Perrin: (12:17) I don't think we can

Stephanie Perrin: (12:17) Apologies for being late; life intervened

Sarah Wyld (RrSG Alt): (12:17) welcome!

Terri Agnew: (12:18) welcome Stephanie

Stephanie Perrin: (12:24) I am going to say this again (reading the chat). WE must remember that all data associated with an individual's file is personal data, even the nameservers. DOes not mean you cannot publish or collect etc etc but you have to acknowledge the potential for reidentification.

Sarah Wyld (RrSG Alt): (12:28) I see 1b up

Berry Cobb: (12:29) In the end, isn't this what Purpose 2 is about? It is considered in my Purpose 2 mockup.

Sarah Wyld (RrSG Alt): (12:30) Berry I dont think they're the same (1b vs 2)

Marc Anderson (RySG): (12:30) I would say purpose 2 is about access to non public data

Sarah Wyld (RrSG Alt): (12:31) 1b is the registrant's own use of the domain, and 2 is access to non-public data to keep the DNS secure/etc

Alex Deacon - IPC: (12:35) so is there some redline missing?

Sarah Wyld (RrSG Alt): (12:51) from purpose A-PA1 lawful basis column

Berry Cobb: (12:51) "(note that registries collection of the data occurs only when the data is disclosed to them by the registrar as per A-PA2)"

Alex Deacon - IPC: (12:51) got it.

Marc Anderson (RySG): (12:59) I think that's right Berry

Sarah Wyld (RrSG Alt): (12:59) I would kind of love to see a GIANT chart of ALL the purposes

Sarah Wyld (RrSG Alt): (12:59) not sure if that's possible but

Marc Anderson (RySG): (13:01) _

Marc Anderson (RySG): (13:01) +1 Alan

Sarah Wyld (RrSG Alt): (13:01) yes, what Alan's saying

Berry Cobb: (13:01) @Sarah, that's my consolidated data elements workbook that I showed when we first started.

Berry Cobb: (13:02) it was by Collection, by Transfer, by Disclosure.

Marc Anderson (RySG): (13:02) it gives contracted parties a good story to tell as to why/how what we are doing is GDPR compliant

Alan Woods (RYSG): (13:02) yes! :) I'm sorry!

Berry Cobb: (13:03) Yes there is required collection by one or both.

Berry Cobb: (13:03) this this example is a bad example.

Berry Cobb: (13:04) This #2 was my representation based on past discussions.....it does not reflect what we're agreeing on.

Alex Deacon - IPC: (13:05) in either case even if this is a purpose or not what would be disclosed is based on lots of variables (legal basis, legit basis, a potential balancing test, etc)

Alan Woods (RYSG): (13:05) I'm sorry Berry. I am much happier where teh workbooks re going!

Sarah Wyld (RrSG Alt): (13:08) As I am happier, having found the giant matrix of all data

Alex Deacon - IPC: (13:11) so IU = Internet Users and LIU = Legitimate Interset Users?

Berry Cobb: (13:12) Yes Alex.

Berry Cobb: (13:13) The public directory seemed to fit here cause its really related back to SSR.

Berry Cobb: (13:13) A quick directory by which peeps can access information so that they may contact their Registrar.

Stephanie Perrin: (13:14) Under GDPR, they should be told who their registrar is on a regular basis. You don't have to look up a registry....

Berry Cobb: (13:15) So if I understand, a future thin whois guery no longer exists? Even on RDAP?

Stephanie Perrin: (13:15) so that has to change in order to be compliant

Sarah Wyld (RrSG Alt): (13:16) I do like this new format. Is anyone intersted in having these all in a google doc/sheet so that we can all submit edits and comments?

Stephanie Perrin: (13:16) You are fading Berry.....strangle that mic

Alex Deacon - IPC: (13:17) In my mind the use case is an rdap/whois query by a user who is not accredited. (i.e. they have no identity and authorization). Could be just domain name, state, country. (and perhaps some others)

Sarah Wyld (RrSG Alt): (13:17) yes- what Alex just said

Sarah Wyld (RrSG Alt): (13:18) the data that was decided in plenary to not redact is what will show up in a whois lookup

Sarah Wyld (RrSG Alt): (13:18) so what I'm not following is why under 2-PA4 the registrant name, street, etc, are required instead of optional

Berry Cobb: (13:19) because the field will still diplay, it just displays as "Readacted blah blah blah legalese" in the field response.

Sarah Wyld (RrSG Alt): (13:20) Ah ok

Sarah Wyld (RrSG Alt): (13:20) thanks Berry

Berry Cobb: (13:20) I can easily subscribe that a public data directory can fit under 3.

Berry Cobb: (13:20) It made sense here in 2, mostly cause it was SSR.

Alan Woods (RYSG): (13:21) I think 3 is a much cleaner sample.

Alex Deacon - IPC: (13:24) in a perfect world with unicorns and rainbows this would be consistent across all RDDS servers.
