The SSR2 Review Team undertook the following during this session:

1. Welcome, roll call, SOI updates

See attendance recorded above. No SOI updates provided.

a. May face-to-face meeting location

Staff confirmed that the ICANN office will be the location for the Review Team's 17th-19th May face-to-face meeting, and advised Review Team members to look out for emails from the ICANN travel team shortly.

b. Kobe meeting dates reminder

Staff confirmed the dates for the Review Team meeting in Kobe are 8th March all day, 9th March all day, and 14th March morning session. Once the schedule is published on 18th February, staff will work with leadership to identify potential times for the Review Team to meet for writing. Pop-up rooms that can be booked close to the meeting start date will be used for these writing sessions. Pop-up rooms do not include tech support.

2. Future challenges workstream discussion

Kerry-Ann led a discussion on how best to move forward with the Future Challenges workstream while the team waits for questions to be answered from ICANN organization. Kerry-Ann proposed that some work could take place in the meantime and that she could work with staff to set up meetings among the volunteers to help with this. Eric noted that there was some duplication between the DNS SSR workstream and Future Challenges workstream with regards to the cryptosystems topic, which was agreed on the call to be moved to Future Challenges only.

The review team discussed each topic in the Future Challenges worksteam and if any outreach beyond the existing questions to ICANN organization needs to take place. For most topics, there was general agreement that no additional outreach was needed at this time.

Action item: Kerry-Ann to work with staff to arrange a meeting with the workstream volunteers for future challenges.

Action item: Cryptosystems topic moved to Future Challenges.

Action item: Coalescence of registrars/registry/backend operators for multiple TLDs – Norm to do some outreach.

Action item: Volunteers to do their own research on other Future Challenges topics.
