REQUEST DESCRIPTION

1. Activity: Please describe your proposed activity in detail
<p>For many years the SSAC has produced and provided a workshop on security and stability issues at the Internet Governance Forum (IGF) based on an SSAC work product such as report or advisory. Each year the SSAC has asked for funding for an SSAC member to travel to the IGF to support this workshop. In 2018, the SSAC took a different approach: 1) SSAC selected a high interest topic based on an SSAC work product; 2) SSAC identified an outreach venue (that might not be include the IGF) for which the topic would be of high interest to that community; 3) SSAC proposed a presentation of the selected topic to the venue. This resulted in a successful engagement with FIRST, the Forum for Incident Response Security Teams which is a long-standing international organization that brings national and private CERTs together. We propose to continue with this approach, which could include a return to the IGF or another engagement with FIRST or another applicable highly visible international security conference. In this special budget request, the SSAC is requesting that ICANN should cover the travel and related expenses for one person from the SSAC to attend and present at the venue, which will be identified early in calendar year 2019. Assistance is requested from Finance to identify the budget estimate.</p>
