**REMINDER: Revised Operational Design Phase Concept Paper**

ICANN org has shared a revised version of the [Operational Design Phase Concept Paper](#). The new version follows community consultation during ICANN69, including written feedback by a number of community groups.

The concept paper proposes an Operational Design Phase (ODP) that is to become part of the policy and implementation life cycle. The ICANN organization will conduct the ODP for consensus policy recommendations that are approved by the Generic Names Supporting Organization (GNSO) Council. The purpose of the ODP is to provide the Board with relevant information to decide, as required by the Bylaws, whether a recommendation is in the best interest of the ICANN community or ICANN.
