Governments are a crucial part of ICANN's multistakeholder model. We also monitor and analyze government and IGO activities to ensure that our ICANN community and our stakeholders are aware of and have the necessary information to address geopolitical issues that could impact ICANN's role and the community's ability to make policy.

The ICANN Office of the Chief Technology Office (OCTO) has published OCTO-032: DNS Resolvers Used in the EU. DNS resolution is typically done either by Internet service provider (ISP) resolvers or by public resolvers. In January 2022, ICANN's Office of the Chief Technical Officer (OCTO) observed that 95% of consumers served by large European Union (EU) consumer ISPs are using their ISP provided Domain Name System (DNS) resolvers.
