### **NEW:** ICANN Continues the Pandemic Internet Access Reimbursement Program

ICANN announced the continuation of the Pandemic Internet Access Reimbursement Program for ICANN75. The hybrid [ICANN75 Annual General Meeting](#) is being held **17–22 September 2022**. The deadline for reimbursement program applications is **2 September 2022**.

Interested ICANN community members must apply in advance of ICANN75, and those who meet the eligibility requirements will be selected to participate. The application process opens **Monday, 08 August 2022**. The application deadline is **Friday, 02 September 2022 at 23:59 UTC**.

The goal of this program is to facilitate participation in ICANN Public Meetings during the pandemic. It offers community members who have limited Internet capacity financial assistance to increase their Internet bandwidth.

Since ICANN75 will be conducted as a hybrid meeting, only applicants that attend virtually are eligible for this program.

This effort is critical to ensuring that the multistakeholder model evolves and meets the changing needs of the ICANN community.
