ICANN Org opened a Public Comment proceeding on a proposed<u>Registration Data Policy</u> <u>Implementation Plan</u>. This plan is the result of three years of work and collaboration including ICANN Org's Policy Implementation Project Team (IPT) and the Community's Implementation Review Team (IRT). The implementation plan includes a draft policy and proposed updates to 20 existing consensus policies and procedures impacted by the Community's recommendations concerning generic top-level domain (gTLD) registration data. The opening of this Public Comment is a tremendous achievement and a true testament to the multistakeholder model at work.

ICANN organization is soliciting proposals to identify a provider to conduct service organization control

audits. The audits are mandated by the various contracts between ICANN and the Internet Engineering Task Force (IETF), the Regional Internet Registries (RIR) and Public Technical Identifiers (PTI).
