#### **REMINDER: EPDP-IDNs Phase 1 Initial Report**

The GNSO Expedited Policy Development Process on Internationalized Domain Names (EPDP-IDNs) is tasked to 1) determine the approach for a consistent definition of all gTLDs and 2) develop policy recommendations that will eventually allow for the introduction of variant gTLDs at the top-level. Its Phase 1 Initial Report, which includes 68 preliminary recommendations, is published for Public Comment from 24 April to 5 June.

The EPDP Team will hold a webinar on **17 May at 11:00-12:30 UTC** to help the community learn more about the key recommendations and facilitate participation in the Public Comment.
