TLD-OPS Update

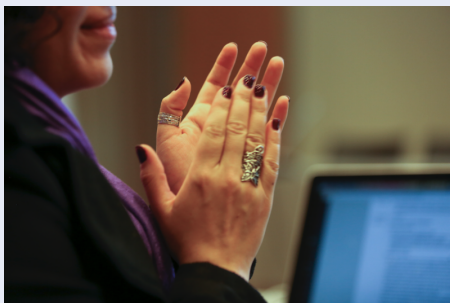
TLD-OPS is the incident response community for and by ccTLDs and brings together folks who are responsible for the overall security and stability of their ccTLD. The goal of the [TLD-OPS](#) community is to enable ccTLD operators worldwide to collaboratively strengthen their incident response capabilities. The TLD-OPS held a Disaster Recovery Workshop at ICANN63, focused on the various aspects of Disaster Recovery that are specific to ccTLDs. The TLD-OPS update in Marrakech will include a short status update on the ICANN63 workshop follow-up.

Over time, the mandate of the GRC was expanded. Currently the GRC also develops the ccNSO internal processes and procedures to underpin the role of the ccNSO as Decisional Participant. In Marrakech the GRC will inform the Council and the broader community on progress to date in these areas.

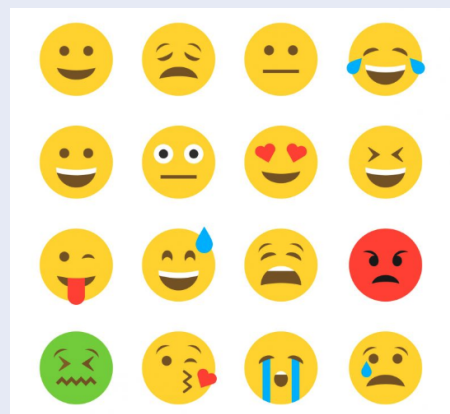
Update by the IDN ccTLD Preliminary Review Team (IDN PRT)

In September 2013, the ccNSO concluded its work on the overall policy for selection of IDN ccTLD strings and inclusion of IDN ccTLDs in the ccNSO. This recommended policy was developed to replace the Fast Track process. As issues emerged with the selection of IDN ccTLD strings under the Fast Track process, by mutual agreement the ICANN Board did not take a decision regarding the recommended policy, to gain experience with the changing methods for string selection under the Fast Track. As a result, the original recommended policy is overtaken by events, due to the refinements under the Fast Track process. Consequently, the original policy recommendations need to be reviewed - and possibly updated - to reflect the current state of play.

The briefing and discussion in Marrakech is intended to inform the ccTLD community and other interested parties on the work done to date by the ccNSO IDN Preliminary Review Team (IDN PRT). The IDN PRT will focus during its briefing on the areas in the recommended policy with respect to the selection of IDN ccTLD strings that need to be reviewed, and possibly updated. In addition, the IDN PRT will inform the community present with respect to the second part of the IDN ccTLD proposed policy on the inclusion of IDN ccTLD managers in the ccNSO. New gTLD Subsequent Procedures PDP. Work Track (WT5): current state of affairs

Following the adoption of the [recommendations](#) of the Cross-community Working Group on the Use of Country and Territory Names as TLDs ([CCWG UCTN](#)) and hence closure of this CCWG, the ccNSO participates in Work Track 5 (WT5) under the GNSO New gTLD subsequent procedures policy development process ([PDP WG](#)). Work Track 5 focuses on developing proposed recommendations regarding the treatment of geographic names at the top-level. The group reached agreement on its Terms of Reference and began substantive

ccTLD Financial Contributions session

After a long and intensive process of community consultation, the ccNSO agreed in 2013 on a [guideline pertaining to the voluntary contribution of ccTLDs to ICANN](#). At previous meetings (ICANN61 and ICANN63), the level of contributions by the ccTLD community was discussed. At ICANN64 the Financial contribution session focused on the administrative issues the ccTLD community and ICANN are facing with respect to the invoicing of voluntary contributions. The goal of the session at ICANN65 is to come to a conclusion regarding the invoicing process, to make it more predictable for all, both for ccTLDs and ICANN going forward. In Marrakech, an update will be provided by ICANN Org on the process and suggested improvements.

The "Post-Transition IANA" organization, filed under the name Public Technical Identifiers ([PTI](#)), is performing the IANA functions pursuant to an IANA Naming Functions Contract with ICANN and subcontracts with ICANN for the performance of the numbering and protocol parameter services. This session includes an update by PTI on the IANA services to the ccNSO, and a short update by PTI Board members.

The CSC provides operational oversight on the IANA naming function as performed by PTI since the transition of the IANA Stewardship. Third Accountability and Transparency Review update and community consultation (ATRT3)

The goal of the Review Team for Marrakech is to:

- Socialize its terms of reference and scope;
- Conduct investigation of identified objectives
- Seek input from the community to help shape its findings and draft recommendations.

The ATRT review is mandated by ICANN [Bylaws](#) Section 4.6 (b) to examine ICANN's execution of its commitment to maintain and improve robust mechanisms for public input, accountability, and transparency so as to ensure that the outcomes of its decision-making reflect the public interest and are accountable to the Internet community. Prior to meeting in Marrakech, the review team met on 3-5 April in Los Angeles for its first substantive meeting to develop our terms of reference and work plan, in response to the Board Resolution ([2018.10.25.15](#)) requesting that "ATRT3 adopt its Terms of Reference and Work Plan within 60 days of convening its first meeting, and submit these documents to the Board and to the leadership of the Supporting Organizations and Advisory Committees, to confirm that the team's scope and timeline are consistent with the requirements of the ICANN Bylaws and ICANN community expectations."

Second Security, Stability and Resiliency Review update (SSR2)

The Review Team has prepared a first draft document, containing about 10 to 15 recommendations, which will be presented to the community at ICANN65. The group continues working on its draft report. Its content will need more discussions, since it contains many more recommendations, which must be aggregated and agreed on in the first step.

Under the [Bylaws](#) (Section 4.6(c)), 'The Board shall cause a periodic review of ICANN's execution of its commitment to enhance the operational stability, reliability, resiliency, security, and global interoperability of the systems and processes, both internal and external, that directly affect and/or are affected by the Internet's system of unique identifiers that ICANN coordinates ("SSR Review").

The advantages of Blockchain and its application in a platform that inherits the Internet Governance model: **Blockchain Federal Argentina.** Julián Dunayevich (.ar)

Blockchain Federal Argentina sets in motion a model that inherits Internet Governance's tools and foundational principles but applied, for the first time, in a framework of Blockchain management at a national level. Moreover, this initiative was designed to ensure interoperability and synergy between similar ventures throughout Latin America and the Caribbean.

Thus, thanks to the impulse of NIC Argentina and representatives of all sectors -civil society, private, local and national government, the academy and research communities- a space was built in which years of experience in a collaborative work could be applied. The result: a platform that, in this collaborative work logic, found the ideal model to consolidate a solid, reliable and open service.

In this context, it is very interesting to analyze how all ccTLDs can find ways to take advantage of the benefits Blockchain has to offer. The ability to improve audit processes and to guarantee transparency and security, makes this new technology the ideal tool to optimize the administration of the registry and at the same time strengthen the DNS infrastructure.

The Pathway to Introducing .au Direct Registration.

In early 2016 the then auDA Board of Directors agreed to introduce direct registration of the .au 2LD. Despite significant internal conflict, government intervention, a change in registry operator and reform of the company structure, this long journey may come to end of the 1st of October, 2019 when Australian consumers will be able to register a .au domain name directly. This presentation will discuss the process, consultation, technical requirements and challenges over this period which may result in the largest change to the .au namespace in 15 years.

The ICANN Bylaws [section 4.4 (a) Section 4.4(a)], call for a periodic review of the performance and operation of each Supporting Organization and each Supporting Organization Council by an entity or entities independent of the organization under review. [Meridian Institute](#) has been appointed to conduct the second ccNSO review. Based on information collected via an online survey and interviews at ICANN63, the independent examiner prepared its assessment and draft recommendations report. In Marrakech, there will be a presentation and community consultation on the draft recommendations. The launch of the 40-day public comment period partially overlaps with ICANN65.
