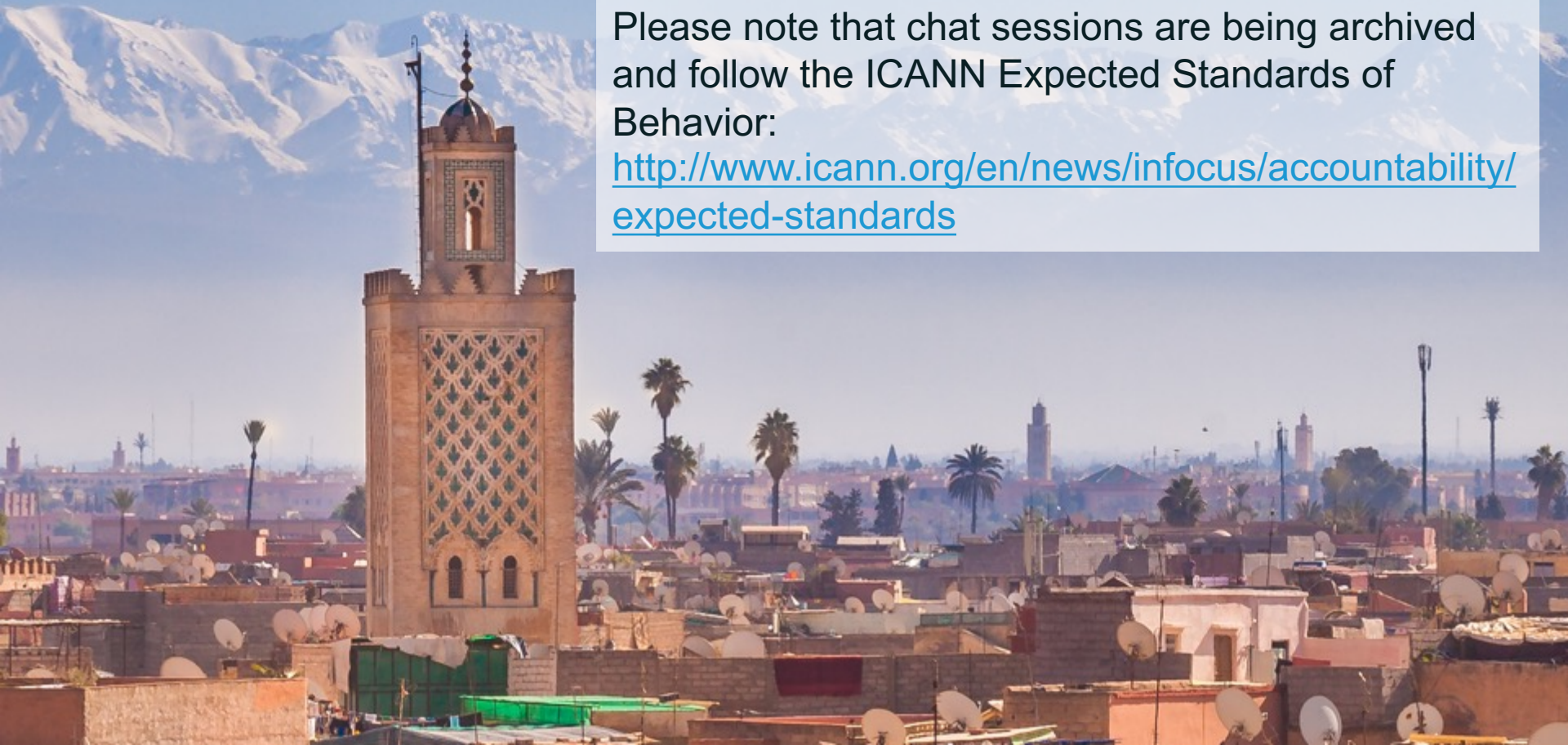

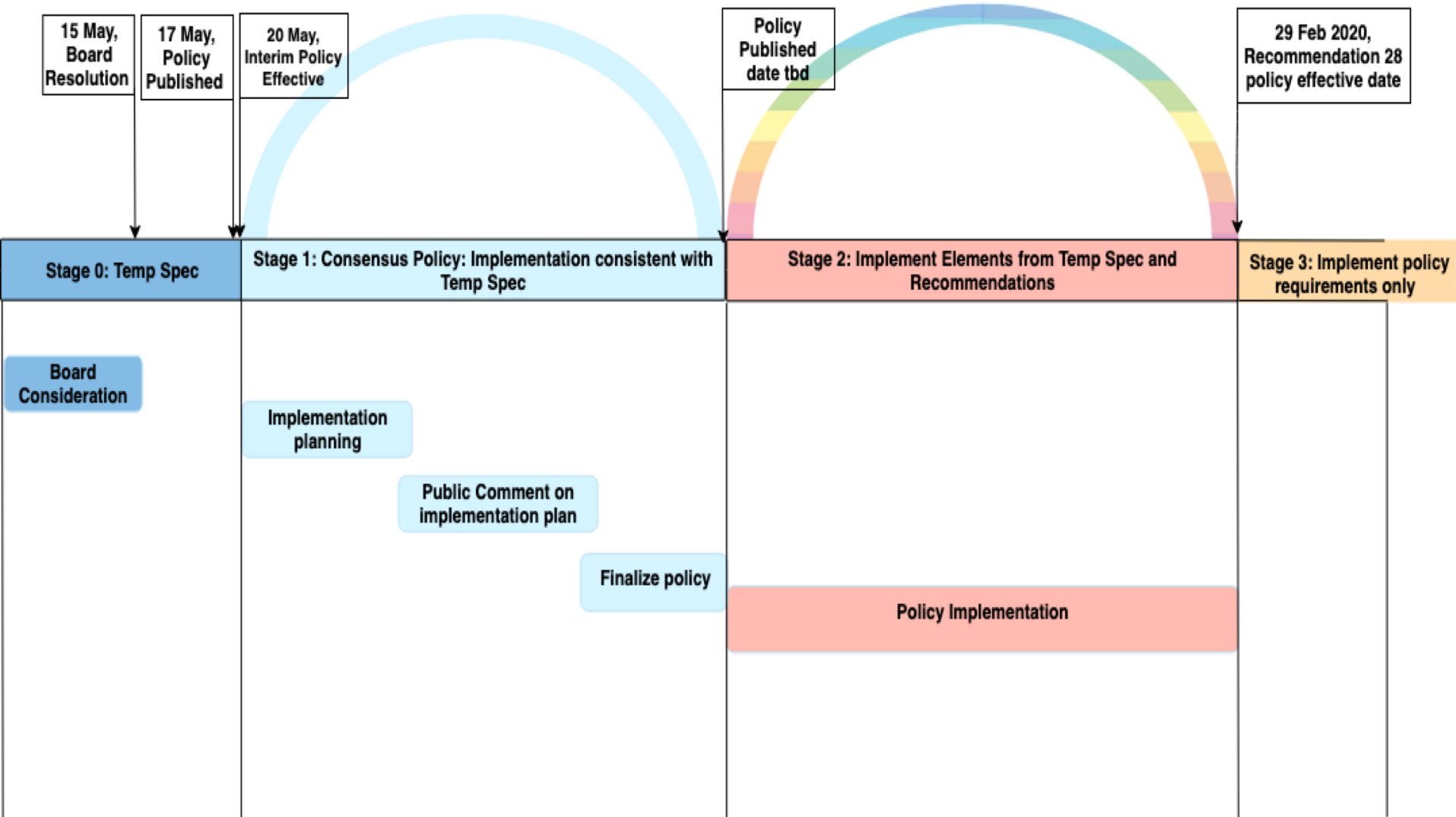

Registration Data Policy Implementation Status

1. The Board adopted the EPDP Phase 1 Final report on 15 May 2019 (two exceptions)
2. Implementation team published the **Interim Registration Data Policy** on 17 May 2019
 - a. Work done in advance with pre-IRT to develop policy implementation in stages (Rainbow Bridge)
 - b. Policy effective date: 20 May 2019
 - c. Temp Spec expiration date: 20 May 2019
3. Call for IRT issued on 20 May 2019
4. Kick-off meeting held with IRT on 29 May 2019
 - a. 28 IRT Members; 34 Observers
5. Implementation team currently engaged in recommendations and requirements analysis
6. IRT meeting at ICANN65: Wed. 26 June 2019 1030AM

Stages of the RegDataPolicy



Thick WHOIS

Requires all gTLD registrations to be "thick," with consistent labeling and display of WHOIS outputs

- Published the two Consensus Policies on 1 February 2017
 - **Consistent Labeling and Display – Implementation Completed**
Policy Effective Date: 1 August 2017
 - **Transition from Thin to Thick for .COM, .NET and .JOBS**
Policy Effective Date: 1 May 2018
 - submit all new domain name registrations as Thick WHOISPolicy Effective Date: 1 February 2019
 - migrate all data required for Thick WHOIS services for existing domain namesBoard has directed postponing enforcement starting

Protection of IGO/INGO Identifiers in All gTLDs

Addresses issues related to the New gTLD Program and whether certain international (non-) governmental organizations (IGOs/INGOs) should receive special protection for their names in top- and second-level domains in new gTLDs

- Published the Consensus Policies on 16 January 2018

- **Protection by Reserved Names - completed**

Policy Effective Date: 1 August 2018

- **Protection by Claims Notification - in process**

Policy Effective Date: 12 months from the release of the Claims system specification

The claims system development may include other identifiers in addition to the currently required INGO Identifiers

Protection for Certain Red Cross Names in All gTLDs

- This is a policy amendment to the published policy for the Protection of the IGO & INGO Identifier for All gTLDs.
- The Reconvene the PDP WG developed a finite, limited list of specific names of 191 Red Cross National Societies as well as a limited, defined set of variants for these names to be added to the reserved names list.
- The Board adopted the recommendation on 27 Jan 2019.
- The Implementation Team is building an implementation plan to publish for the Public Comment preceding
- Currently, the IRT is reviewing the 7047 DNS Labels that have been converted from the list of names
- Target date for the policy publication is 1 Feb 2020 with 1 Aug 2020 effective date

Translation and Transliteration of Contact Information

Facilitates entry of contact information into domain name registration data and directory services by non-English speakers and users of non-ASCII scripts.

- IRT convened July 2016
- Policy implementation is dependent on implementation of RDAP, which supports:
 - Internationalized scripts
 - Exchange of language/script tag data and translated/transliterated registration data between registries and registrars
- Once RDAP implementation is complete, the policy language will be finalized and published for public comment

Privacy and Proxy Services Accreditation

Replaces requirements for registrars accredited under the 2013 Registrar Accreditation Agreement (RAA) on privacy and proxy registrations offered through affiliates and resellers

- ICANN org believes it should wait until EPDP is finished to finalize PP, which will allow ICANN org and the community to focus resources on finalizing requirements for existing contracted parties before proceeding to implement similar requirements for a completely new category of contracted parties
- ICANN org alerted the GNSO Council to this status on 4 Mar2019 to which the Council replied on 30 Apr 2019 <https://gns0.icann.org/sites/default/files/file/field-file-attach/drazek-et-al-to-namazi-30apr19-en.pdf>
- ICANN org is reviewing and will follow up as necessary

GNSO Council action on PDP Final Report:

- Approved Recommendations 1-4 in April 2019; transmitted related Recommendations Report to ICANN Board on 16 May 2019.
- Did not approve Recommendation 5 – issue referred to RPM PDP to be considered as part of its Phase 2 work.

Current Status:

Recommendations 1-4:

- ICANN Bylaws require Board to act, following a public comment period and notification to the GAC by the ICANN Board.
 - Does not preclude discussions among/with GAC, GNSO & Board

Recommendation 5:

- GNSO Council discussing re-charter of RPM Working Group
 - Proposal for a small, representative group of experts (international law, international intellectual property, alternative dispute resolution)
 - Essential for GAC & IGOs to participate in order to develop workable policy
