Public consultation = multistakeholder participation?



Public consultation

- Common practice in many states and regions
- Seeks to involve those potentially affected by or interested in a decision: individuals, governments, institutions, companies or any other entities
- Seeks to enhance accountability
- The right to public participation is enshrined by law to protect human rights in many places (e.g. the Philippines, the US)

National ICT Ecosystem Framework (NICTEF) of the Philippines

- A five-year ICT masterplan (successor to the Philippine Digital Strategy 2011-2016)
- A multi-stakeholder approach was adopted
- An inclusive, bottom-up policymaking model by letting people set the agenda and goals of the country's digital strategy
- "Going beyond open public consultations"
- Developed with stakeholders from diverse sectors in dialogues and discussions
- A living document: plans and projects are updated periodically as the government continually considers comments from society
- Updates are available on the website





"...while it may not be possible to include all stakeholders in the process, the more inclusive and transparent the process is, then the more likely it is to produce workable outcomes and to engender the requisite trust and support of those outside the process."

Four stages of development

- 1. Preliminary activities (Dec, 2017)
 - Including an introductory event, two awarenessraising workshops, and a training course for civil servants to broaden understanding of the principles that underpin the architecture and evolution of the Internet
 - Prought together a small group of stakeholders from the public and private sectors to brainstorm the scope and direction of NICTEF, and the process for developing it





Four stages of development (cont.)

- Focus group discussions (May July, 2018)
 - Six thematic focus group discussions involving government agencies, the private sector & academia
 - A short online survey (on SurveyMonkey) to solicit views from citizens on what the priorities should be. Responses were used to inspire and facilitate detailed discussions in focus groups
 - A three-day "writeshop" to bring together ICT govt officials & consultants to develop first draft





Four stages of development (cont.)

- Regional consultations (Oct Nov 2018)
 - Done in the three major island groups of the Philippines – in Luzon, Visayas and Mindanao – and in Metro Manila to understand the needs and concerns of constituencies
 - Participants were from key sectors in national and local government, the private sector, academia, civil society, and the technical community.













Four stages of development (cont.)

- Public online survey (Oct Nov, 2018)
 - Done in both the national language, Filipino and in English to include citizens' views on ICT issues that affect their day-to-day lives


 Throughout the entire programme, the government opened its doors to input from stakeholders who could not make it to the consultations





Some good practices

- 1. The team responsible for the multi-stakeholder approach has a common understanding of what it is, and commitment to stand by it
- 2. They try to be inclusive
- 3. Conduct face-to-face public consultations to hear from stakeholders in rural and remote areas
- 4. Tailor the multi-stakeholder process to the culture of the country
