Impact of COVID-19 Pandemic

Majority of the **NRI meetings** scheduled for February-June 2020 are postponed. **EuroDIG 2020** will be the first NRI meeting hosted completely online (10-12 June).

Impact on IGF 2020 processes

- The Host Country, UNDESA/ IGF Secretariat continue to monitor the situation.
- Current situation indicates high probability of hosting the 2nd Open Consultations and MAG meeting through online participation platforms (*initially scheduled to be hosted Geneva, Switzerland from 16-18 June*).
- The planning of the 15th annual IGF meeting continues with the objective for the meeting to be hosted onsite in Katowice from 2 to 6 November.

IGF 2020 Thematic Tracks

DATA

This track will focus on discussions on the fundamental challenge of ensuring the benefits of the data revolution to contribute to inclusive economic development while protecting the rights of people.

ENVIRONMENT

This track aims to understand the interdependences between the use of Internet and digital technology to preserve the environment, but also to threaten its sustainability. It will consider how the positive impacts of ICTs for climate action can be enhanced while minimizing any negative impact.

INCLUSION

Inclusion track aims to engage the IG community on the issues, challenges, and solutions for the achievement of an equitable and inclusive Internet.

TRUST

It will provide opportunities to discuss strategies and best practices for protecting both systems and users, along with the appropriate roles and responsibilities of governments, industry and other stakeholders, while taking into account multidisciplinary perspectives.
