Background (1/2)

- **ccNSO council decision | 5 November 2018**

The ccNSO Council decides not to support the CCEG Charter and to rescind from the CCWG IG / CCEG. Taking into account the high level of support by the ccTLD managers present in Barcelona for continued lightweight coordination and the recognised need to liaise with different groups under the ICANN umbrella and other groups deemed relevant to coordinate the sharing of basic information on Internet Governance events considered relevant by the ccTLD Community, the ccNSO Council requests its Chair to propose the Terms of Reference for a lightweight coordination/liaison committee. The committee should include at least two Council members and one member of the broader community. The effectiveness of the committee will be reviewed one year after it has been established.
