Proposed by some members of the IRT: 60-minute weekly

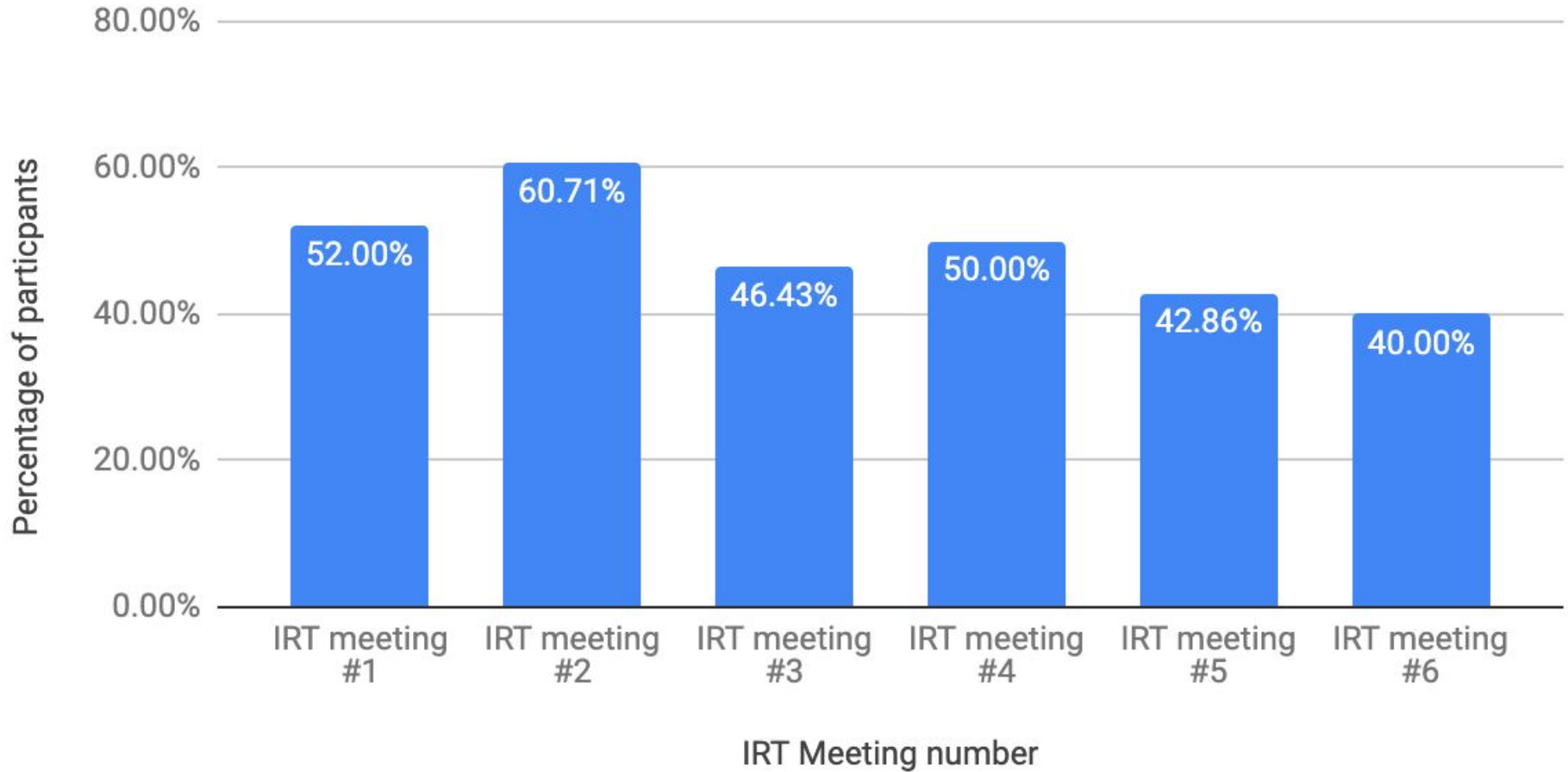
## Alternatives

## IRT Meeting Attendance

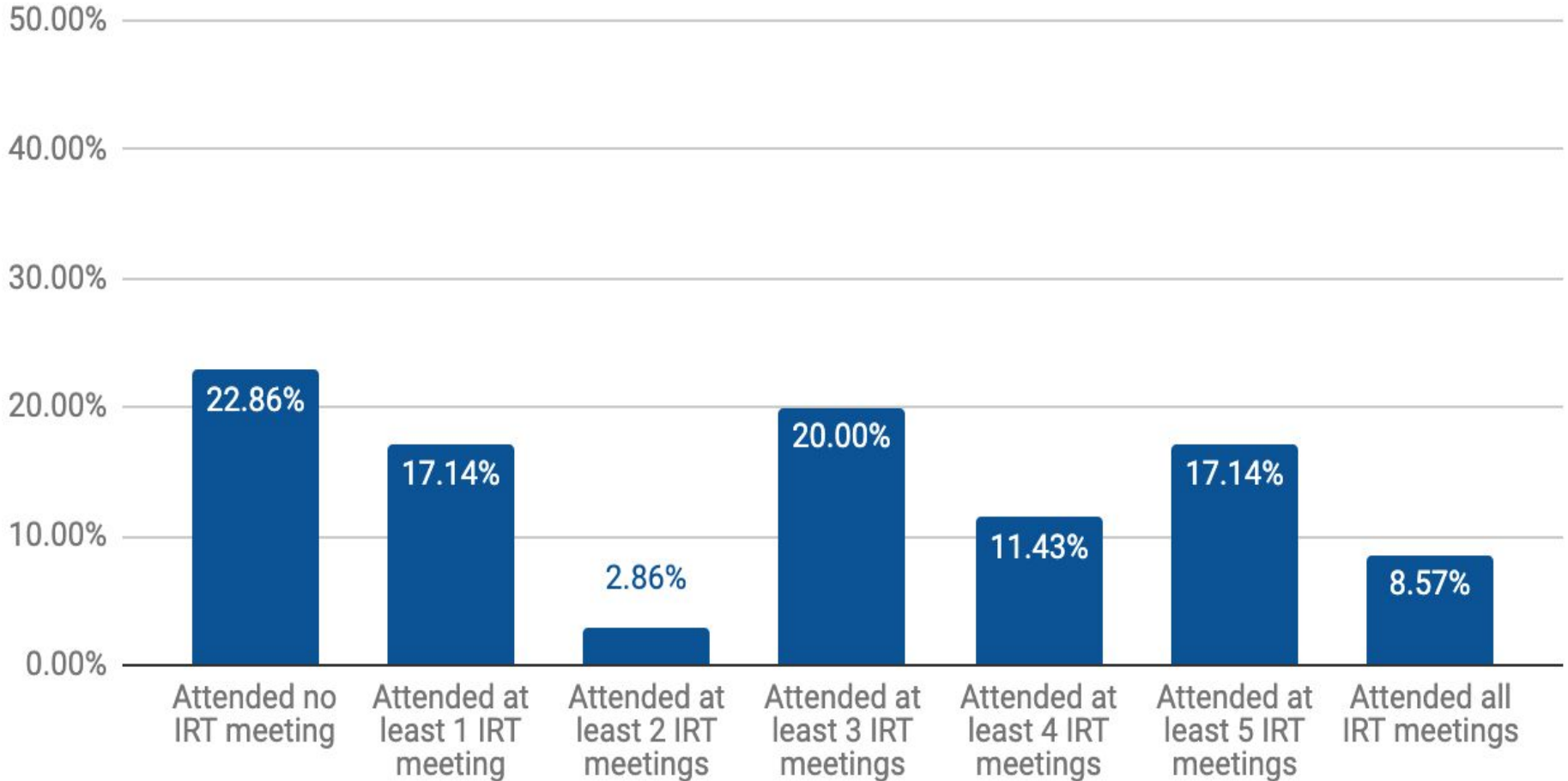
Total attendance per IRT meeting

1. IPT continues recommendations and implementation requirements analysis for IRT review
2. IPT begin merging recommendations document to the main policy language document
3. IPT builds the implementation plan for IRT review
4. IPT prepares the material for the public comment proceedings for IRT review
5. Open public comment
6. Next IRT meetings scheduled (90 minute sessions)

  - Wed. 02, 16, 30 October 2019
  - ICANN66 session in planning: requested two 90-minute IRT sessions 06 & 07 November
