The ATRT3 Review Team undertook the following during this session:

1. Welcome, roll call, SOI updates

See attendance recorded above. Michael noted he has updated his [SOI](#).

2. Any work party items for plenary attention (Board, GAC, Reviews, Community, IRP, WS2)

Work party leads provided an overview of work progress to date:

- **Board** – No updates provided.
- **GAC** – Vanda reported that the work party are aligning on updated objectives and will incorporate these into the Google doc once agreed.
- **Reviews** – Daniel reported he’s working with KC to update the work party objectives as the assessment of ATRT2 will be addressed at plenary level. He also noted that the work party has requested a cost for previous reviews.
- **Community** – Michael reported that the work party will have a meeting on [16 July](#), before which Erica and Michael will send some notes around to guide the discussion. He also noted that the survey results will be important to the work party’s work.
