

Completed in prior period(s):

- A proposed <u>implementation plan</u> was shared with the GNSO Council on 10 December 2018 for review.
- At the GNSO Council Strategic Planning Session at the end of January 2019, it was agreed that a small team of Councilors would be formed to work on implementation of all recommendations contained in the PDP 3.0 implementation plan. The small team held its first meeting at ICANN64 and has begun meeting on a bi-weekly basis.
- The small team has agreed to provide updates to the Council no less frequently than
 once a quarter, with the most recent update taking the form of a discussion topic on
 the GNSO's working session agenda at ICANN65 and an item on the GNSO Council
 meeting agenda. In an effort to enhance progress, the group has agreed to meet on a
 weekly basis, assign staff/small team member leads to each item, and has made other
 changes to how it operates.
