### **Report from the Chair of the At-Large Advisory Committee to the 40<sup>th</sup> Meeting of ICANN in San Francisco, USA**

#### **At-Large Activities at the 40<sup>th</sup> ICANN Meeting in San Francisco, USA**

During the 40<sup>th</sup> ICANN Meeting that took place 13-18 March in San Francisco, USA, the At-Large Community was represented by a total of 29 members from all five At-Large regions. These representatives included Members of the At-Large Advisory Committee (ALAC), officers of the five Regional At-Large Organizations (RALOs), representatives of At-Large Structures (ALSes), At-Large liaisons, At-Large delegates to the Nominating Committee (NomCom), and representatives of the At-Large Community.

The very well-attended NARALO Showcase highlighted the diverse North American Regional At-Large Organization. Dr. Vint Cerf presented the keynote speech on “Amplifying the Voices of Civil Society” and nine At-Large Structures gave overviews of their activities and achievements.

At-Large played a key role in the organization and running of two cross-constituency meetings:

The At-Large members that participated in the 40<sup>th</sup> ICANN Meeting actively took part in non-At-Large meetings as well. They prepared [reports](#) of these sessions, which provided summaries of the sessions as well as highlighting issues of importance to the At-Large Community.

Among the many policy and process-related issues discussed during their meetings, there are several the ALAC would like to highlight:

- **At-Large Improvements project nears completion** - The four At-Large Improvements Work Teams (WTs) have made significant progress since the Cartagena Meeting. During the Silicon Valley Meeting, the At-Large Improvements WT's focused on their final implementation proposals, including receiving feedback on them from the ALAC, RALOs and broader At-Large Community. The WT's are on schedule to conclude their work by approximately the end of March.
- **ALAC and GAC agree to develop closer relations to strengthen outreach activities** – Representatives of the ALAC and the GAC met on Sunday, 13 March to discuss common interests and how to strengthen ALAC-GAC relations. It was agreed to hold ALAC-GAC sessions at all ICANN meetings and to begin regular written communication between the two advisory committees.
- **At-Large Standing Working Group established to identify emerging challenges to At-Large and how to address them** – The ALAC adopted a motion to create a new At-Large Working Group which will discuss emerging challenges to At-Large and the ALAC and how they should be addressed. The first task of WG will be to propose a limited list of priority issues which the At-Large community should address in the near future, because of their impact on the global Internet, on ICANN, and on ALAC. These issues shall constitute the core of the work program of the WG for 2011.

### **At-Large Activities since the 39<sup>th</sup> Meeting of ICANN in Cartagena**

The At-Large community, consisting of the ALAC, five RALOs and 130 At-Large Structures, continued to its policy-making and outreach activities between the 39<sup>th</sup> ICANN Meeting held in Cartagena, Colombia in December 2010 and the 40<sup>th</sup> ICANN Meeting held in San Francisco, California, USA held in March 2011.

During this time-period, the ALAC submitted 8 policy statements to the Board.

## At-Large Improvements – Status and Next Steps

Since ICANN’s 39<sup>th</sup> Meeting in Cartagena, the four At-Large Improvements Work Teams (WTs) have remained on schedule, making significant progress toward concluding their work by approximately the end of March.

### *Progress and ALS involvement*

The table below summarizes the progress made to date in implementing the 13 recommendations that, originating in the [Final Report of the ALAC Review Work Group on ALAC Improvements](#) (Feb 2009), define the goals of the Improvements Project. As shown, the role of the four Improvements WTs in implementing each of these recommendations is either finished or nearly finished – only six months after these WTs began meeting.

Even more striking than this progress has been the extensive “bottom-up” approach taken by the ALAC and At-Large in this work. The Improvements Project has truly been conducted and led by the At-Large “edges” – that is, by the regional ALSes and their members. Of the eight co-chairs of the Improvements Work Teams (WTs), the majority (five) are *not* ALAC members; furthermore, the majority of WT members, by far, come straight from the ALSes.

Since the goal of the At-Large Improvements Project is no less than the enhancement of the ways in which the ALAC and At-Large conduct their business, the RALOs’ and ALSes’ leadership of this Project has ensured their widespread – and very beneficial – influence on our Community for years to come.

## ***At the Silicon Valley Meeting***

During the past week, at ICANN's Silicon Valley Meeting, the At-Large Improvements WTs have focused on their final implementation proposals – receiving feedback on them from the ALAC, RALOs and broader At-Large Community, as well as formally presenting most of them, during Thursday's [ALAC & Regional Leadership Wrap-up Meeting](#), for the ALAC's consideration.

Examples of some of the more notable proposals presented by the WTs include the following:

- WT A (on the ALAC's continuing purpose) proposed that the ALAC submit to the Board amendments to ICANN Bylaws that would clarify the continuing purpose of the ALAC within the ICANN structure;
- WT B (on ALS participation) proposed that the ALAC initiate a training and education program, to coincide with ICANN Meetings, for new ALS members;
- WT C (on ALAC planning processes) proposed that the ALAC initiate, develop, and maintain an institutional knowledge management and retention system for At-Large; and
- WT D (on ALAC's policy advice development) proposed that the ALAC adopt a new Policy Advice Development process (PAD) that incorporates (a) earlier document translation and education of the ALSes about policy issues, (b) multiple points at which extensions of the public comment period may be requested, and (c) the development of a Policy Review Committee (PRC) to help inform the Community of upcoming policy comment periods and bundle related comment periods.

## ***Next steps***

Immediately following ICANN's Silicon Valley Meeting, these next steps will occur:

- WT B will finalize its work in developing proposals for the ALAC regarding the implementation of Recommendation 9 (enhancing ICANN's interpretation and translation tools);
- WT C will finalize its work in developing proposals for the ALAC regarding the implementation of Recommendation 5 (enhancing ALAC's strategic and operational planning) and 6 (developing more accurate cost models for ALAC/At-Large activities); and
- WT D will finalize its work in developing proposals for the ALAC regarding the implementation of Recommendation 12 (increasing the input from consumer groups into the ALAC's policy advice process).

Following the completion of these steps, the WTs, in collaboration with the ALAC and the At-Large staff, will be ready to draft the final report regarding the ALAC/At-Large Improvements Implementation Project, to be submitted to the

ALAC for approval. Once approved, the ALAC will submit this report to ICANN's Board.
