Meeting notes :

Mark S.(WG chair) started the meeting by reviewing the previous meeting(s) action items, he reiterated the WG members agreement to speed up the drafting process and aim to complete the best practices document before or by the WG meeting of 14th of July.

The chair requested the WG members to review the document add comments or edits.

Regarding the WHATWG discussion, since the last meeting Mark D. drafted a mail letter for the Chair to be sent to WHATWG, the chair has shared it with his Microsoft browser's group contacts. The issues are already on the WHATWG GitHub repository, that's good because people are reviewing the issue even this month. The chair indicated that the best way to get results is to file an issue, which already has been done in the letter and the proposed list of supporters are fine and carries the weight of policy and compliance behind it.

The Chair will seek the support of Microsoft's browser team first, then will finalize and share a WHATWG email letter regarding the existing issue and share it with the WG. The Browsers support is need be included in WHATWG email letter.

The chair extends the congratulations to everyone who worked with Apple on iOS 14 support of EAI on their email client. Apple indicated in its announcement that they will be supporting the Indian scripts for the Indian market.

The WG members continued drafting the [Best Practice for Mailbox Name. \[docs.google.com\]](#), the group completed the initial drafting of the following sections :

- Aliases and display name consideration
- Signs and Symbols
- Variants Considerations

The normalization section was skipped, and a draft text needs to be added to the document.
