Meeting Notes

Due to the time zone change in the US and Canada, the meeting time has been changed to 1500 UTC.

Finalizing SOW – Popular Web Hosting Tools:

There have been some updates on the SOW document where the WG members discussed and finalized these areas. Purpose and description of the SOW have been updated to make it clearer. With this SOW, our aim is not to measure ISPs. We're testing control panel tools, but also control panel tools as deployed, together with web servers, email servers and database components that are used by ISPs. So, the purpose is to make sure that those tools make it possible for websites to provide universal acceptance.

As this type of work is done for the first time, and because of that it is not comprehensive, it was mentioned in the SOW as a pilot phase.

Vendors should pick combinations of components which are representative of what ISPs are likely to use in real life. The combination will be diverse and flexible as per suggestion of the vendor. The test cases will be included at a high level in the proposal. This will allow the applicants' expertise level as well. The detailed plan will be prepared after contracting. Once the community reviews the plan, vendor will update it before performing the test.

In this meeting, the SOW document for popular web hosting tools were finalized. As a next step, the draft SOW document will be shared in the mailing list with the Measurement WG members. After receiving their inputs in one or two weeks, we will finalize it and share with the Coordination WG. After receiving Coordination WG inputs, we will update and take it further to the Leadership Team for their review and approval. After the approval, it will be posted on ICANN Wiki SOW page.

What to take up next from the FY22 Action Plan:

Based on the Action Plan, the WG reviewed what has been done, and what is left to do. Following options were suggested:

- M2: **Content Management Systems** other than Wordpress
- M2: **eCommerce Platforms** such as Shopify and some of these platforms which allow to develop ecommerce websites
- **Single sign-on solutions** are not listed in the action plan. However, this topic was discussed earlier.

Social Media Applications and Browsers study are already done. 1000 website analysis is also no more an option as it is taken care of by another SOW.

The group prioritized the next tasks as follows. However, other WG members will be consulted to see if there are any other suggested major topics to take up next.

- 1) Single Sign-On Solutions
- 2) Testing more content management systems (CMS)
- 3) eCommerce platforms
