



Total domain name registrations (ccTLDs & gTLDs):







ccNSO

ICANN Policy Development body, which shall be responsible for:

- Developing and recommending to the Board global policies relating to country-code top-level domains;
- Nurturing consensus across the ccNSO community, including the name-related activities of ccTLDs;
- Coordinating with other ICANN Supporting Organizations, committees, and constituencies under ICANN;
- Nominate individuals to fill Seats 11 and 12 on the Board;
- Other responsibilities as set forth in these Bylaws.





ccNSO

Policies that apply to ccNSO members by virtue of their membership are **only** those policies developed according to Section 10.4(j) and Section 10.4(k). However, the ccNSO may also engage in other activities authorized by its members. Adherence to the results of these activities will be **voluntary** and such activities may include: seeking to develop voluntary best practices for ccTLD managers, assisting in skills building within the global community of ccTLD managers, and enhancing operational and technical cooperation among ccTLD managers.





ccNSO

ICANN policies shall apply to ccNSO members by virtue of their membership to the extent, and only to the extent, that the policies (i) only address issues that are within scope of the ccNSO according to Section 10.6(a) and Annex C; (ii) have been developed through the ccPDP as described in Section 10.6, and (iii) have been recommended as such by the ccNSO to the Board, and (iv) are adopted by the Board as policies, provided that such policies do not conflict with the law applicable to the ccTLD manager which shall, at all times, remain paramount. In addition, such policies shall apply to ICANN in its activities concerning ccTLDs.






ccNSO

The ccNSO shall have a membership consisting of ccTLD managers. [..] a ccTLD manager is the organization or entity responsible for managing an ISO 3166 country-code top-level domain, or under any later variant, for that country-code top-level domain.
