It has been suggested via public comments that transparency and openness should also include publishing budget/financial data on each constituency's website.
	The new, more useful and informative web site is long overdue. After discussions with the ExCom and specialized third parties, the new version should happen in Q2 2009 and shall include, among others, the mailing list archives, the agendas of previous and upcoming meetings, as well as a list and short bio of each of Constituency officers.	As indicated in the report, at present, interested parties must go to several different sites/pages in order to locate information about the Registrar Constituency. While the new site is still under construction, as a transition step, perhaps it would be helpful to include all existing/current links accessible from the new "beta" site to make it easier for visitors and users to find information. Also, on the new site, Staff notes that the posted link to "Agenda for Upcoming RC Meeting" takes the visitor to a page which reports, "Login required to edit."

1.1	The Registrar Constituency of ICANN's Generic Name Supporting Organization (GNSO) is constituted according to Article 5, Section 1, Part B of the Bylaws of the Internet Corporation for Assigned Names and Numbers.	Should be amended to read "Article X, Section 5" of the ICANN Bylaws.

The impression is left that "Task Force" representatives are elected by the Constituency (on a semi-permanent basis) vs. being appointed/selected based upon circumstances and needs. Given that individuals can "self-select" into Working Groups, perhaps the sections dealing with Task Forces should be rewritten.
3.3.2	The term of a GNSO Council Representative is two years. A GNSO Council Representative may only serve two consecutive terms for the same position	The charter is silent on whether a GNSO Council Representative, who previously met a term limit, may be reelected after sitting out one or more years.
3.3.3	The term of a Task Force Representative shall be equal to the duration of the Task Force that they have been appointed to, or two years, whichever comes first. There are no limits to the number of consecutive terms that a Task Force Representative may be re-elected to.	Revise to reflect the transition to "Working Groups" within the GNSO. In addition, consider appointing, selecting, or requesting volunteers vs. electing semi-permanent positions to serve in this capacity.

Staff could not find it mentioned anywhere in the charter.

Non-Registered Representatives of Members in good standing are also eligible to be nominated to stand as candidates for Constituency election to offices covered by Section 3.1.4.
