MINUTES

Call to order

Ted Hardie called the teleconference to order at 22:03 UTC and reviewed the proposed agenda. There were no objections to the agenda.

Administration

Carlos Reyes reviewed the minutes for teleconference 34 on 5 August 2021 and teleconference 35 on 2 December 2021. There were no objections to publishing the draft minutes.

ACTION ITEM: Carlos Reyes to publish the approved minutes on the workspace.

Potential charter adjustments

The RSS GWG continued its discussions about potential adjustments to its charter. Ted Hardie outlined three options:

1. No changes
2. Include all RSOs and require consensus
3. Include observers

Geoff Huston, Brad Verd, Hanyu Yang, Hiro Hotta, Lars-Johan Liman, and Suzanne Woolf preferred the second option. Kurt Pritz preferred the first option but agreed to support the majority. As liaisons, Duane Wessels and Tripti Sinha did not have any comments, and Kim Davies and Akinori Maemura deferred to the RSS GWG.

Ted Hardie explained that the request to the ICANN Board will note the risk about the RSS GWG being composed with a preponderance of RSOs. This concern can be balanced through a strong consensus requirement.

ACTION ITEM: Ted Hardie to send to the RSS GWG mailing list a draft response to the 2 December 2021 letter from the ICANN Board.

While the ICANN Board and RSOs consider this request, the RSS GWG will review its proposal for success criteria in RSSAC058. Geoff Huston proposed comparing, contrasting, and understanding the rationale and differences between the RSSAC037 model, the RSS GWG proposal, and RSSAC058. Hanyu Yang agreed.

Any charter adjustments may also prompt changes to the work plan for RSS GWG members to consider as part of their appointment and commitment.

Any other business

There were no additional agenda items.
