MINUTES

Call to Order

Brad Verd called the teleconference to order at 22:04 UTC and reviewed the proposed agenda. There were no objections to the agenda.

Review Draft Minutes of Teleconference 42

Review Draft ICANN74 Schedule

Carlos Reyes shared the draft schedule of GWG sessions during ICANN74.

Engagement and Discussion of RSSAC058

Brad Verd introduced Robert Carolina. Robert Carolina highlighted the principles of RSS governance and the role of the RSOs in RSS governance. The success criteria provide a framework for conversations about evolving RSS governance, especially for writing foundational documents of future structures. Governance is about what people and entities do. Wes Hardaker asked what happens if a success criterion is not met. Robert Carolina suggested that it is up to the GWG to articulate a vision of what the success criteria mean for its work. Ultimately, the output of the GWG has to be approved by its stakeholders. Duane Wessels expressed concern that the success criteria may lead to prolonged conversations about specific, minor details. Lars-Johan Liman explained that the GWG will have to discuss and decide how to proceed when success criteria contradict or are in conflict with each other. Suzanne Woolf stated that RSSAC037 clearly identifies the stakeholders of the root server system. Robert Carolina noted that he will capture observations and questions for further discussion.
