9a. FY20 SOAC Chairs' Flexibility Fund

PILOT PROJECT: FY20 FLEXIBLE FUNDING TO FACILITATE POLICY DEVELOPMENT & ADVISORY ACTIVITIES BY ICANN'S SUPPORTING ORGANIZATIONS AND ADVISORY COMMITTEES

Objectives:

This proposal is intended to provide funding, on a pilot basis, for specific, identified projects or activities within ICANN's Supporting Organizations and Advisory Committees (SOACs) that:

- Are timely, important and not requested or otherwise budgeted for in FY20;
- Facilitate effective participation in ICANN policy and technical work; and
- Enhance SOACs' efficiency in performing their policy development and advisory work.

Scope:

Any and all projects and activities to be funded from this pilot initiative must primarily be based on one or more of the five strategic goals outlined in the Draft FY21-25 Strategic Plan, which are:

- 1. Strengthen the security of the Domain Name System and the DNS Root Server System;
- 2. Improve the effectiveness Of ICANN'S multi-stakeholder model Of governance;
- 3. Evolve the unique identifier systems to continue to serve the needs of the global Internet user base;
- 4. Address geopolitical issues impacting ICANN's mission to ensure a single and globally interoperable Internet; and
- 5. Ensure ICANN'S long-term financial sustainability.

Funding will be limited to projects not otherwise budgeted for in the core FY20 budget; but funding will not be available for "second bites" at projects or activities that were proposed but not ultimately accepted for funding under the core FY20 budget.



9b. FY21 Additional Budget Requests

FY21 ALAC/ALT Plus Criteria for Additional Budget Requests: (TBC)

- In the post-ATLAS III environment, proposals should include activities that will make the entire At-Large community more effective in policy advice development.
- Activities to improve engagement with existing members is encouraged.
- Outreach should not be a major focus. The CROP program or RALO Discretionary Funding can be used for outreach.
- RALO requests should be strategic and in line with their RALO's strategic outreach plans and must be endorsed by their RALO prior to being submitted for consideration by the FBSC.
- Priority will also only be given to those who have provided draft reports as requested as part of the FY20 ABR approval language. Final reports must be submitted by the end of FY21. For Details see: At-Large FY20 Additional Budget
