ICANN EXCHANGE WITH THE EDPB

- ❑ ICANN President and CEO Göran Marby received a non-binding letter from the Belgian DPA in response to ICANN org's paper, "Exploring a Unified Access Model for gTLD Registration Data"
- ❑ The Belgian DPA encouraged ICANN to continue its efforts to design a comprehensive system for access control that takes into account the requirements of security, data minimization, and accountability
- ❑ The response did not provide any definitive opinions regarding the questions that ICANN org included in the paper

ICANN EXCHANGE WITH THE EDPB

- ❑ The Belgian DPA has indicated their willingness to further discuss this effort and have invited ICANN org staff to meet with them
- ❑ The letter states that the policy and relevant safeguards that the community will develop to be applied in a UAM will be extremely important to assess whether a centralized model increases or decreases the level of protection enjoyed by natural persons
- ❑ The EPDP team will discuss the letter before the F2F meeting in LA

SSAD COST ESTIMATE

- ❑ On November 23rd the Chair of the EPDP team Phase 2 wrote to the CEO and president of ICANN seeking input on the financial sustainability issues of the SSAD
- ❑ The SSAD would most likely involve ICANN managing or operating a centralized system to facilitate requests for disclosure of non public registration data
- ❑ The EPDP team's questions were in relation to the cost implications to develop, operationalize and run such a system

SSAD COST ESTIMATE

- ❑ **Answer** - Should the EPDP come to consensus on an SSAD model, ICANN org believes it is part of its public responsibility to ensure that the system is cost efficient by, for example, issuing RFPs and taking other steps to ensure the system is appropriately resourced to ensure the security and stability of the world's Internet users
- ❑ **Answer** - ICANN takes seriously its mission, which includes a longstanding, historic commitment to Registration Directory Services
- ❑ **Answer** - The development of a possible Unified Access Model is extremely important and the EPDP has a very important role to play in recommending policy, including identifying a financial model

SSAD COST ESTIMATE

❑ **Answer** - ICANN org would like to confirm its understanding of the three models for which the EPDP team is seeking estimates

❑ **Answer** – ICANN org is examining the following costs:

Developing technical specifications

System development

System support/maintenance (including enhancements and bug fixing)

System operation (e.g., customer support, other human resource operators, system operation)

And periodic auditing

SSAD COST ESTIMATE

- Answer** - the team working on the cost estimate is formulating some questions about the EPDP's assumptions. These estimates would be discussed with the EPDP team in LA in January
- The EPDP team will discuss this response early January before our F2F meeting in January
