At-Large Advisory Committee (ALAC)

What to Expect

During ICANN78, the At-Large Advisory Committee (ALAC), Regional At-Large Organizations (RALO) leaders, At-Large liaisons, and other At-Large community members will hold 18 sessions in the three At-Large work tracks of policy, outreach and engagement, and operations. The sessions will include two plenary sessions, individual sessions focused on policy, outreach and engagement, and operations, four joint sessions, four RALO sessions, a session marking the 20th anniversary of the ALAC, two sessions for incoming and continuing leaders, an At-Large welcome session, and a wrap-up session.

Background

At-Large is the community of individual Internet users who participate in the policy development of ICANN. Currently, more than 250 At-Large Structures (ALSes) and over 160 individuals organized into five RALOs that represent the views of individual Internet users.

The ALAC consists of 15 members and serves as the primary organizational home within ICANN for individual Internet users. The role of the ALAC is to consider and provide advice on the activities of ICANN as they relate to the interests of individual Internet users.

The work of the At-Large community takes place primarily in working groups divided into three tracks: policy; outreach, engagement, and capacity building; and operations. At-Large conducts its work through regular teleconferences and active participation during ICANN Public Meetings.

Session Details

For ICANN78, there are two priority topic sessions selected by members of the At-Large ICANN78 Planning Committee.

WSIS+20: Toward an Engagement Strategy

The 2025 review of the WSIS implementation is regarded as a critical opportunity to reaffirm support for the multistakeholder model. During ICANN78, At-Large will hold a session to discuss the process of ensuring broad participation in the WSIS+20 because it will take place in a highly structured multilateral space.

The session strives to update the community on the current stage of the process and propose intervention strategies for stakeholders to adopt. Participants will include representatives from the ICANN community and ICANN org.

The Impact of Technological Advancements on ICANN: Ensuring the Management of Unique Identifiers Remains Efficient and Effective

This ALAC-hosted discussion will focus on how the Internet landscape is constantly evolving through emerging technologies and protocols. The session will look at how ICANN and its stakeholders are adapting to these changes to ensure that the management of unique identifiers remains efficient and effective.

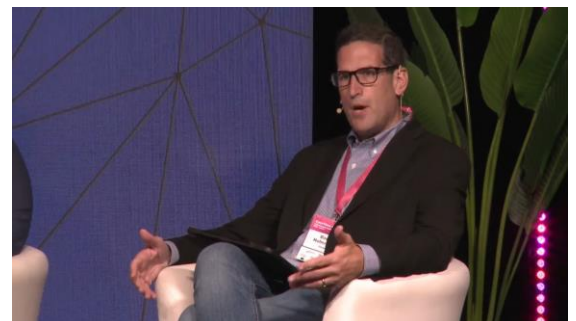

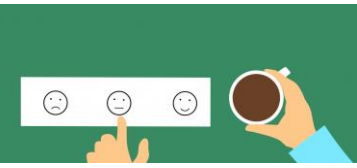

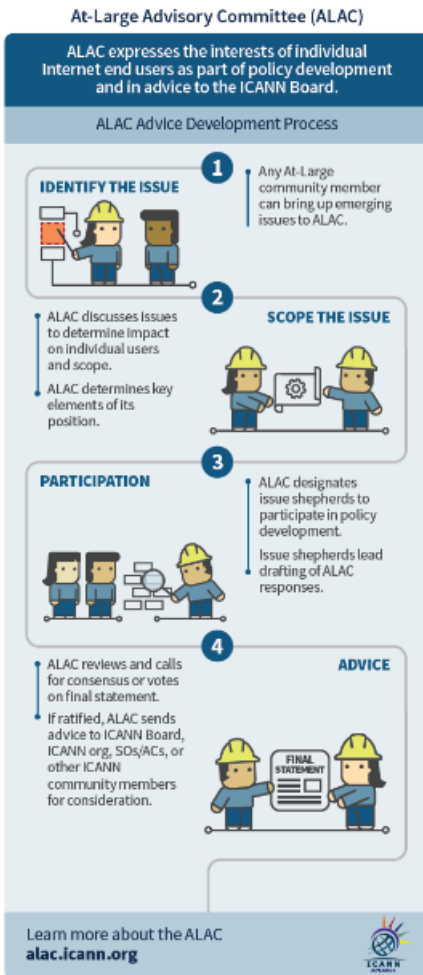
