



ALAC Advice Development Process Any community member can bring up emerging issues to ALAC SCOPE THE ISSUE ALAC discusses its relevance to end users and decides if it. needs to respond. ALAC determines if issue is in scope. DEVELOP ADVICE ALAC appoints At-Large community member to lead small team to write draft statement and begin consultation. Anyone may contribute to draft statement. RATIFY ADVICE ALAC reviews and calls for consensus or votes on final statement. Ifratified, ALAC sends advice to ICANN Board. #### **Revised Community Travel Support Guidelines**

The ALAC noted that At-Large is unique within the ICANN community in that virtually all volunteers in At-Large activities, including those involving travel, do so as true volunteers. Without ICANN travel support, the number of active At-Large participants at ICANN meetings would be few in number. The ALAC specifically commented on wire transfer and foreign exchange fees/losses, visa reimbursement, travel insurance, ICANN arranged travel, room guarantees, forced overnight delays, early check-in and late check-out, as they pertain to the successful participation of the community during ICANN meetings.

### Middle East and Adjoining Countries (MEAC) Strategy 2021-2025 Note: Joint AFRALO-APRALO Statement

The AFRALO and APRALO joint statement was the first joint RALO statement within the At-Large Community, in response to the ICANN MEAC Strategy 2021-2025. The countries that fall under the MEAC Strategy within AFRALO and APRALO provided feedback on strategy topics as security, ICANN's governance, unique identifier systems, and geopolitics.

This report provides a high-level overview of the planned work and activities of the Supporting Organizations and Advisory Committees during ICANN68, including expected activities, background, processes, projects and plans of At-Large Advisory Committee (ALAC)

During ICANN68, the At-Large community, including the At-Large Advisory Committee (ALAC) members, Regional At-Large Organization (RALO) leaders, and ALAC liaisons, will hold 11 sessions to discuss policy issues of interest to At-Large and to individual Internet users.

The At-Large community will also hold several sessions on: DNS abuse, Public Interest Commitments (PICs) and PIC Dispute Resolution Procedure (PICDRP) improvements, new generic toplevel domain (gTLD) applicants, and Universal Acceptance.

#### **At-Large Capacity Building Webinars**

We would like to thank the coordinator of the Capacity Building webinar team Hadia El Miniawi who talks about CB webinars which have become the new learn platform not only for At-Large members, but also attract a lot of visitors from the ICANN community and beyond:

"On the first Monday of every month, the At-Large Capacity Building Working Group (CBWG) webinar team is running a webinar to the At-Large and the entire ICANN community. The webinars' topics focus on capacity building as well as ICANN hot topics and policies under development. The aim of the webinars is to engage more people in the community, expanding their knowledge and encouraging their involvement in ICANN policy development processes and discussions. The first of these CBWG webinars was in April, the topic presented was on the EPDP on the Temporary Specification of the gTLD Registration Data. The speakers were ALAC representatives to the EPDP, Alan Greenberg from NARALO and Hadia El Miniawi from AFRALO. The presenters discussed the background and rationale for the EPDP, the privacy legislation and the outcomes of the EPDP Phase 1, the concept of a Standardized System for Access and Disclosure (SSAD), the proposal for an SSAD as well as some open issues like the differentiation between the registration data of legal and natural persons and the accuracy of the registration data. The second webinar was held on the first Monday of May and was about DNS abuse from an end user perspective. The presenters were Jonathan Zuck from NARALO and ALAC Vice Chair and Drew Bagley from the secure domain foundation. The speakers provided an overview of the different types of DNS abuse and some of the efforts by ICANN and At-Large to combat it. In addition, recent surge in DNS Abuse related to the COVID-19 pandemic and how to protect yourself against it was discussed. The presentation included Q & A and a survey was presented to the participants at the end of the webinar. The third webinar was on Monday June 1. The topic discussed was Geopolitics and Cybersecurity. Joanna Kulesza from EURALO and ALAC Vice Chair was the webinar lead and the speakers were Leon Sanchez, ICANN Board Vice Chair, Veni Markovski ICANN Vice President for UN engagement and Javier Rua Jovet ALAC NARALO representative. The webinar included an update about the UN processes potentially affecting ICANN's mission and a review about ICANN Board's progress and further plans to ensure due representation of the ICANN community in the current geopolitical trends.
