- ***Action item #4: [completed]***

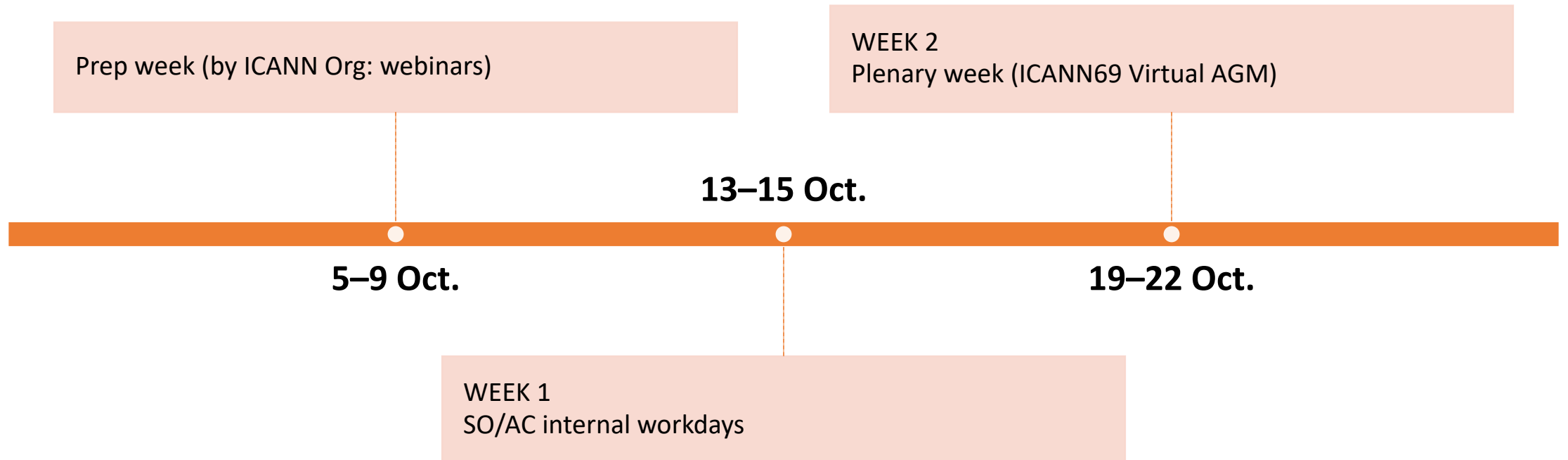

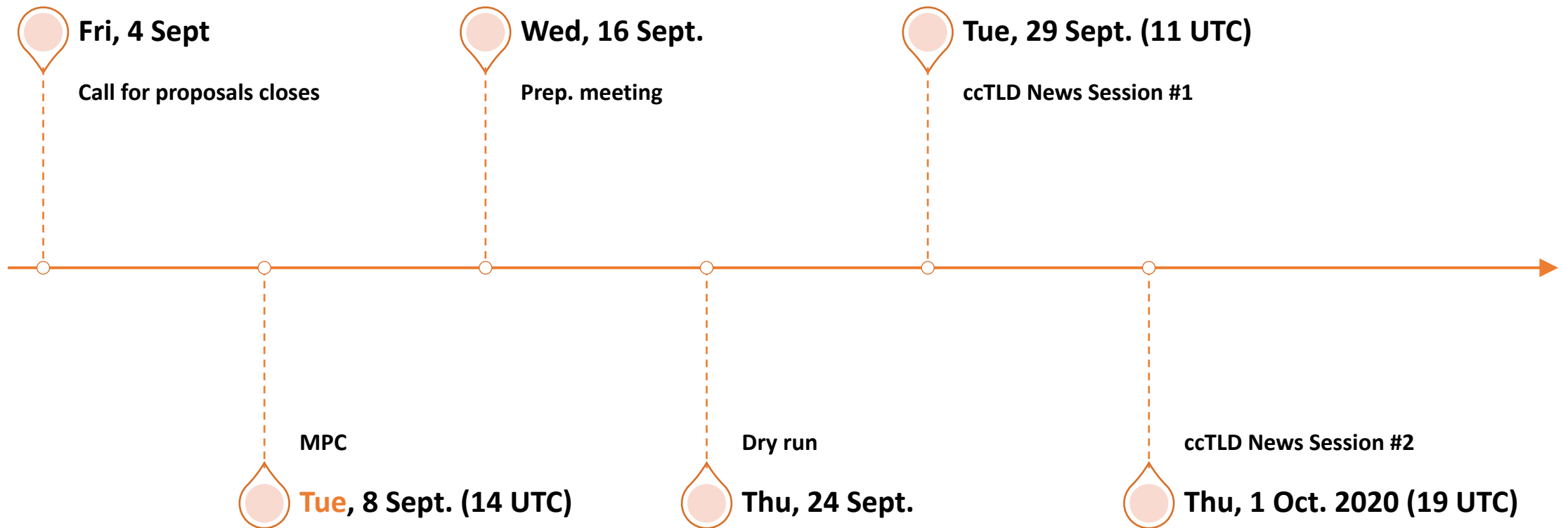
