The SSR2 Review Team undertook the following during this session:

1. Welcome, roll call, SOI updates

See attendance record above. No SOI updates provided.

2. Approach to completion of the final report

Russ advised the team of the steps that will occur in the coming weeks as the team prepares the final report, expected to be as follows: During next week's meeting the abuse subteam will present the abuse text to the full team. They are currently making changes to the text as discussed on last week's plenary call. Once the abuse text is agreed, Heather will compile the full report (1-2 weeks) and distribute to the team for a read-though. Then, once the team has read through and discussed any outstanding items, a consensus call will be taken on the report.

3. Subteam updates (see subteam status spreadsheet [here](#)):

- Recommendation 25 (see document [here](#) beginning p54): KC provided an overview of the proposed text. The team agreed that the recommendation is ready to move into the draft final report document. This recommendation will also become part of the abuse section – Heather will incorporate as appropriate.
- Recommendation 28 (see document [here](#)): Naveed provided an overview of the changes. KC suggested that Naveed check the 'Mitigating the Risk of DNS Namespace Collisions' [study](#) and ensure the recommendation reflects findings of the study. Naveed will do this and incorporate comments made during the call and circulate the revised text to the email list for team agreement in the coming days.
- Recommendation 23, 26 (see document [here](#)): Žarko provided an overview of the updates he and Heather made to the text since the team last looked at the text. Team members suggested minor edits to the text, which Žarko will incorporate. The

team agreed that once the minor edits are made this text is ready to move into the draft final report document.

Action item: Naveed will incorporate comments made on the call into the recommendation 28 text and share updated text to the list for final comments.

Action item: Žarko will make the minor adjustments as discussed to recommendation 23 and 26 text and advise Heather once this is done so that she may move the text into the draft final report document.
