The portal will be managed and maintain by ICANN, and presumably, the abuse claims will have some detail such that ICANN will be able to direct the abuse claim to a party e.g. registrar / registry. The text also proposes that registries will be required to use the portal. But other than presumably receiving the abuse claims (fwd'ed by ICANN), what other use does this team suggest registries will be required to? The text is not clear, or actionable enough. IMO.
