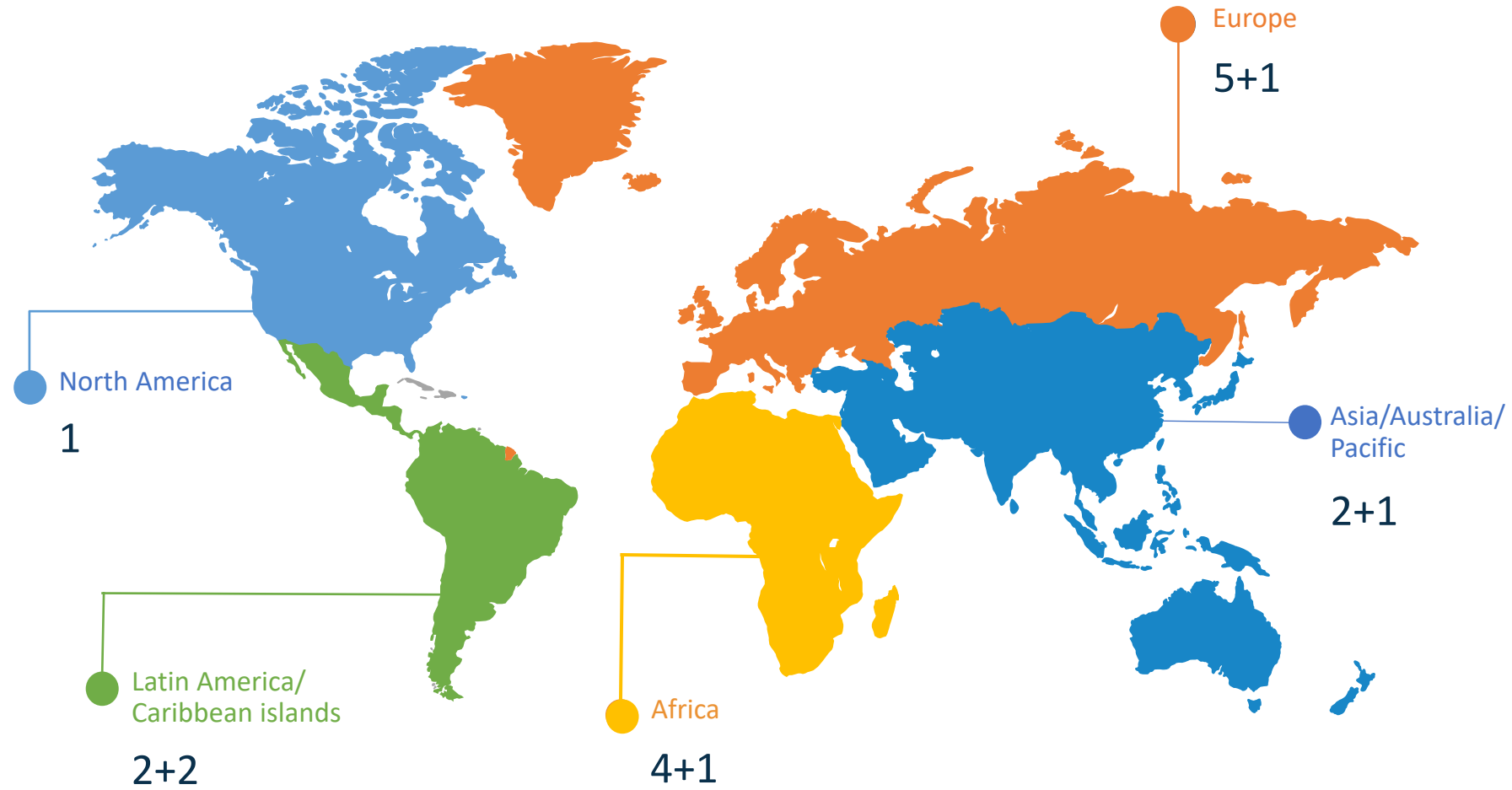

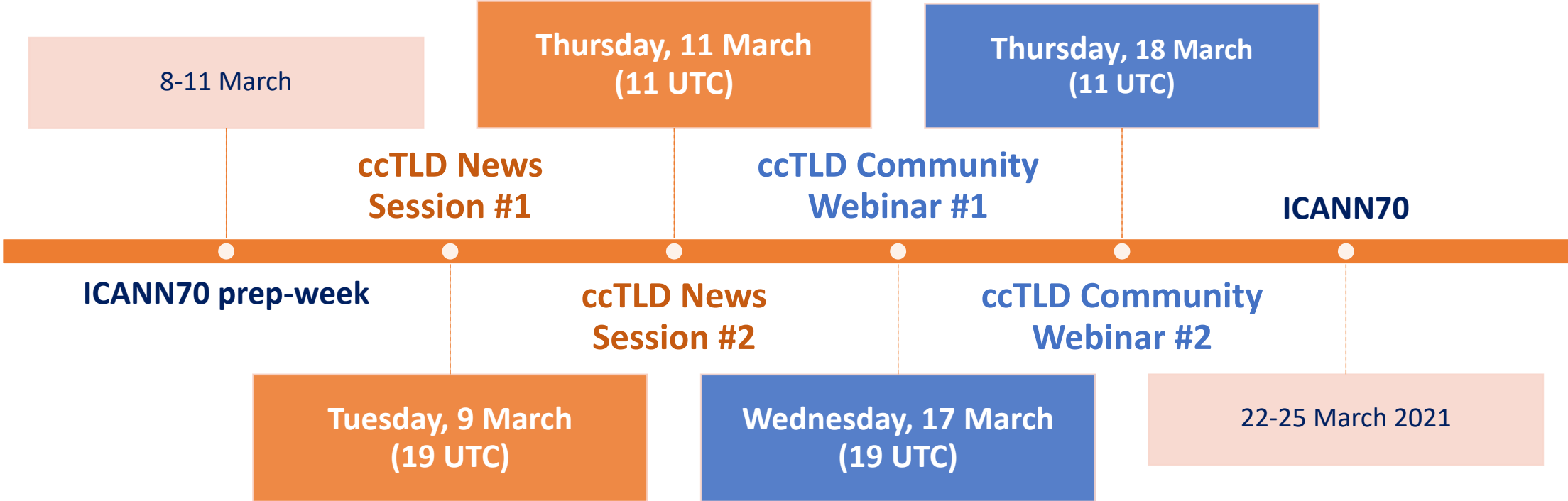

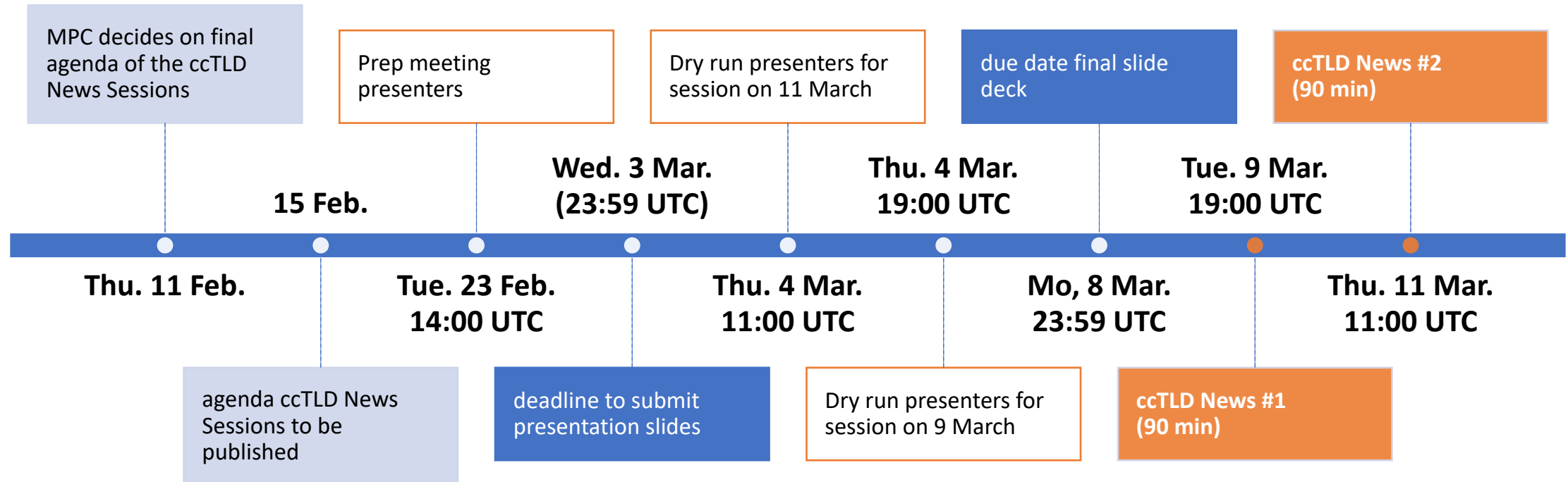

Study on the benefits, drawbacks, and evaluation of independent registry management (IRM, SRM - Sistem Registri Mandiri)

Since 2020, PANDI runs its own registry system. The registry would like to do more research and development in the area of policy, documentation, relations, trouble-shooting, governance, and foundation to improve its own system and share how it can also be beneficial for other registries.

Sustainability plans for registries

The Swedish Internet Foundation, AFNIC, EURid and DNSBelgium all have sustainability programs. In 2020, consultants from Ecolife (a Belgian firm known to DNSBelgium) have helped the registries compare their sustainability metrics to find shared models for measurements and performance indicators. The outcome is a report with a small set of baseline measurables in a registry and suggestions for how to set up a sustainability plan in a registry. The report is available to the CENTR membership. The CENTR sustainability team aims to:

- Make it easy for registries to start sustainability work
- Reduce barriers to sustainable practices in registries
- Enable cost-saving sustainability – it is possible to save money and the planet at the same time!
- Share objectives, while staying true to local circumstances

Members of the CENTR sustainability team have committed to share this work with the community and make their expertise available to ccTLDs.
