Dear APRALO Community -

Greetings!

We have just completed the ICANN72 Virtual Annual General Meeting, again in the virtual mode. Further, it was also announced that ICANN73, originally proposed to be held in the hybrid mode at Puerto Rico, would be fully virtual as well.

ICANN72 addressed several policy-related aspects in the ALAC Policy Track, the most prominent of them being DNS Abuse, Closed Generics and ICANN Accountability, Transparency, and ICANN Reviews. The At-Large Advisory Committee (ALAC) also met with the Governmental Advisory Committee (GAC) to discuss topics of mutual interest, including ICANN and governments, DNS abuse, and a reflection on public interest processes. The ALAC also met with the ICANN Board, discussing topics such as the need to work more closely with governments globally, as well as engage, train, and interact with governments on geopolitical issues relating to the ICANN mission, and the System for Standardized Access/Disclosure (SSAD).

In the Outreach & Engagement track, RALO leaders and members participated in regional leadership activities to focus on policy topics, outreach, and engagement activities. The North American Regional At-Large Organization (NARALO) also hosted social networking sessions. Meetings of different At-Large working groups such as At-Large Consolidated Policy Working Group (CPWG), At-Large Operations, Finance and Budget Working Group (OFBWG), and ALAC Subcommittee on Outreach and Engagement took place in advance of ICANN72.

Since the 2021 AGM was over during ICANN72, there have been some changes to the Leadership Team of APRALO. Justine Chew, ALAC member, has taken up a new position as ALAC's Liaison to GNSO. In her place, we have a new NomCom appointee to the ALAC, Naveed Bin Raees. We thank Justine for her very dedicated policy efforts during her tenure. We also welcome Naveed to not only ALAC Policy-related responsibilities, but also to APRALO's organizational and outreach-related work. We also would like to thank Amrita Choudhury for her very meticulous work for her two NomCom terms. NomCom work is quite heavy at the best of times, and now with travel restrictions in place, there were also the significant constraints caused by time-zone issues. In her place, we have Ali AIMeshal who joins the NomCom. I thank Amrita and congratulate Ali on his new role.

Wishing that our community remains safe in these difficult times.

We always knew that October was going to be busy, and with three weeks of ICANN meeting it certainly was way busier than usual. The ICANN Prep week provided a great introduction for At-Large by way of a "fireside chat" with staff representatives of each of the ICANN sections. Silvia Vivanco explained all the different activities that At-Large was presenting during At-Large Week and ICANN Week, as well as a general invitation to two social events that NARALO had organised for "their Seattle meeting". These turned out to be a lot of fun.

At-Large week followed and this was our "work week". Despite not being held during the ICANN week. It did spread out the load and replaced other meetings that might have been held that week - using up two or three hours over each of the three days. We started the week with a programme that welcomed new ALAC and At-Large leaders; provided end of year workstream updates; and introduced our policy topics - covering the need for Generic tlds(or not); different approaches to Tackling DNS Abuse; and an interesting overview about ICANN Accountability from all over the ICANN community. This was organised by EURALO and was very fast-paced but great to get the different perspectives of a potential holistic review.

The ALAC met with three groups over the two weeks - the SSAC to introduce two recent security advice documents; the GAC where our policy experts shared the At-Large position with their GAC counterparts; and finally with the Board for whom At-Large provided some (great) ideas on how they might engage more effectively with governments. The final event for At-Large was firstly a farewell to departing ALAC and a welcome to incoming ALAC members, followed by the Wrap-Up with members of the Board, including incoming Board member from, Edmon Chung of DotAsia, an At-Large Structure. Edmon was appointed to the Board by the NomCom. All in all it was a long three weeks, but we covered a lot of ground and At-Large can be very proud of themselves. We now commence a New ICANN Year, and my final one as the ALAC Chair. I'm looking forward to making it yet another productive year for At-Large, as ALAC Chair. ☺

ICANN72 Update



ICANN72 Virtual Annual General Meeting was held from 25-28 October 2021. However there was a [ICANN72 prep week](#) held between 12-14 October.

The sessions of the Prep week were mostly updates from ICANN Org and the SOs/ACs or capacity building initiatives. They include providing an update on ICANN Reviews and Implementation Status; a

GNSO Policy update; planning and prioritization framework design update; a policy update, a Root Zone Label Generation Rules update; Introducing the DNS Security Facilitation -Technical study group; a contractual compliance update; a NomCom update; and a Global Public Interest at ICANN update. In addition, Fellowship and NextGenmembers. , Also an update was provided on the ICANN org Risk Management Framework, Progress and next steps for UA and a guide for newcomers on ICANN72.

During the AGM week, there were two plenary sessions (Q&A with ICANN Org Executive Team and Designing Hybrid ICANN Public Meetings to Equalize In-Person & Remote Participation); the ICANN Public forum, the 23rd AGM; community sessions that included a Joint Meeting of ICANN Board with Noncommercial Stakeholder Group (NCSG), with the ALAC, with the Commercial Stakeholder Group (CSG), with Root Server System Advisory Committee (RSSAC), Generic Names Supporting Organization (GNSO) Council; Joint meeting GAC with ALAC, GAC with GNSO; Security and technical sessions that include the Tech day sessions, RSSAC meeting, Security and Stability Advisory Committee (SSAC) public meeting, Domain Name System Security Extensions (DNSSEC) and Security Workshop; Country Code Names Supporting Organization (ccNSO) Council meeting. Further sessions were organised to seek community input on GNSO EPDP-IDNs and discussion on the GNSO Transfer Policy Review PDP Working Group.

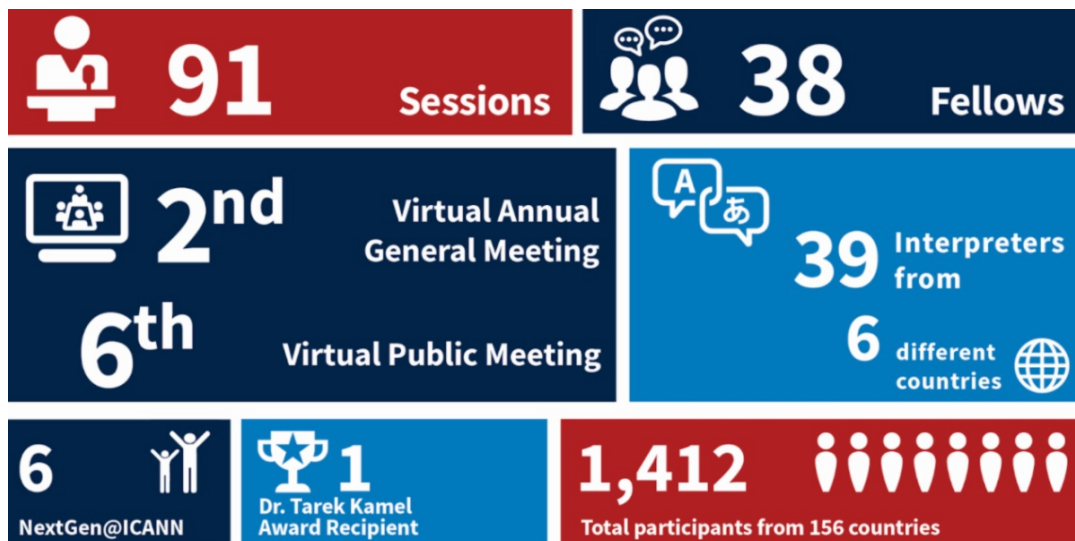

And (2) Tackling DNS Abuse and ICANN Accountability and Transparency and the ICANN Reviews. 'There was also an ALAC & SSAC Meeting and an At-Large Trivia Event, hosted by NARALO During the AGM week, At-Large held the Leadership Transition and Leadership Wrap Up session.

- Signed a [Memorandum of Understanding \(MoU\) with the North American Network Operators' Group, Inc.](#) (NANOG)
- Announced plans to jointly organize the [Asia Pacific \(APAC\) region's first Domain Name System \(DNS\) Forum](#) with MYNIC Berhad, the Registry and Registrar for .MY.

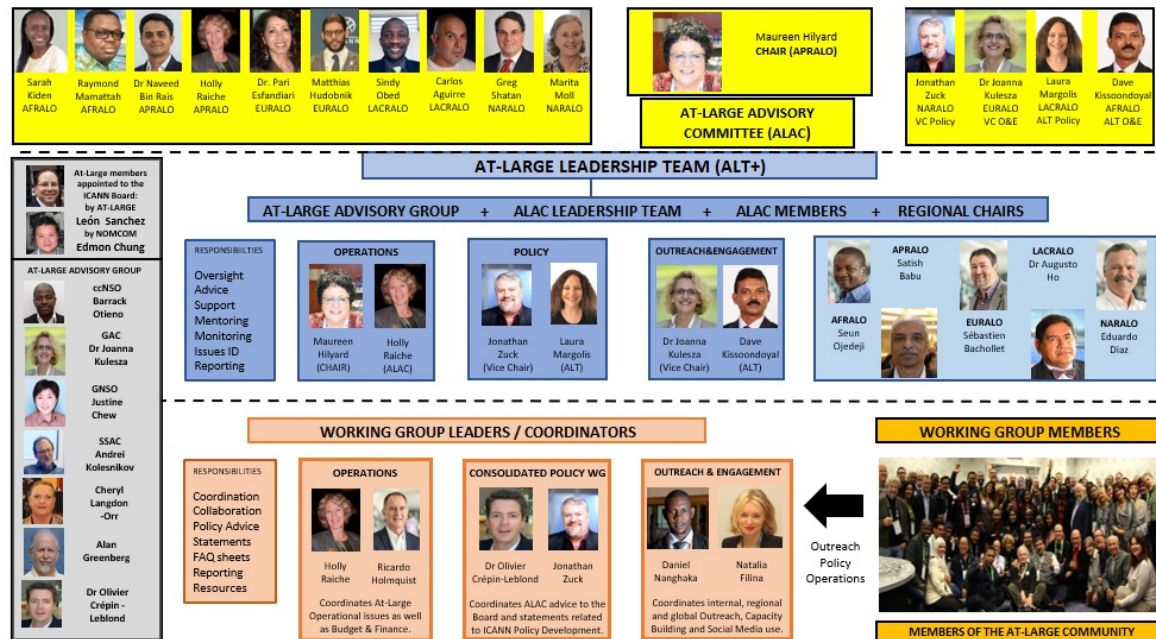

The APRALO Register of Skills & Interests (RoSI) Project small team has taken the project as far as it can for now and that small team is presently contemplating a collaboration with the APRALO Hot Topics Survey (HTS) 2021 small team to conduct a RALO-wide feedback on its work. The APRALO Hot Topics Survey (HTS) 2021 small team had its first coordinating call on 13 October 2021 to discuss the approach for the 2021 survey. During that call, members of the small team concluded that in planning this survey, more in-depth consideration ought to be given to various factors, including careful reflection of areas to cover, concise crafting of questions and selection of an appropriate tool to conduct the survey in order to, both, maximize the quantity and optimize the quality of feedback from RALO members. To this end, the small team members felt that the HTS project should not be constrained to an unreasonable timeline, since the collection of useful responses is paramount to strategically inform the RALO's direction for the next few years. APRALO ALS Update



Armenian School on Internet Governance, 5th edition | 18-19 September, 2021

ArmSIG – the Armenian School on Internet Governance is a capacity building program aimed at different stakeholder group representatives across Armenia. The fifth edition of the School was designed for journalists working in Armenia and interested in Internet governance related hot topics.

On 18-19 September 2021, Internet Society Armenia Chapter and the Armenian ccTLD Registry co-organized the 5th edition of the ArmSIG as an in-person meeting in Aghveran, Armenia. During the 2-day special course, the selected 21 participants, mainly journalists and PR specialists, were actively involved in various format discussions. Invited speakers first introduced the Internet ecosystem, including the I* organizations activities – ICANN, ISOC, etc. and later revealed the topics included in the program at length.

Although the 2-day program was fully packed, the fact that participants stayed in one hotel and could socialize beyond the program hours, made the event very successful. It also helped in creating bonds among participants. Moreover, a special Facebook group was created where all participants could interact and share information with each other, even after the completion of the program.

Upon the completion of the course, the participants were awarded Certificates.

Armenian Internet Governance Forum, 6th Edition | 8 October, 2021

On 8 October, 2021, the 6th Armenian Internet Governance Forum, was organized jointly with the Youth IGF Armenia to advance the outreach and inclusive discussions on local digital policy issues and current challenges in the country.

This one-day in-person event brought up 3 panel sessions on Hate Speech, Online Education and E-Health as well as provided the floor for presentations on other major topics. For the first time, a Town-hall session was organized on topics of Internet Freedom and Cybersecurity.

The other novelty was the sign-language interpretation in Armenian, making the forum more inclusive for community members.

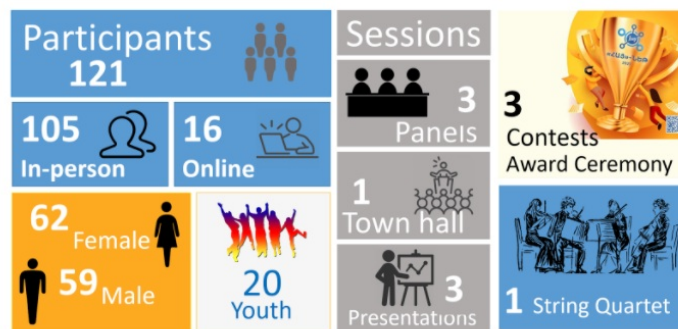
The discussions reflected the challenges that emerged in the country not only due to the pandemic, but also to the war that happened last year. All participants agreed that in the time of crises, the Internet was a critical tool. On the one hand, it served to connect people, to provide vast opportunities for education, for business, for health issues and all other aspects of daily life. On the other hand, we witnessed how it can be manipulative, destructive and harmful to society.

The discussions summed up mostly with the following:

- all emerging issues should be openly discussed,
- the government should be more collaborative with other stakeholders,

- there is no place for the hate speech and, measures to eliminate it, should be balanced so that not to constrain the right of the freedom of speech,
- the education system, though technically adapted to the online environment, needs to improve its curriculum and systemic approaches, as well as be inclusive for people with disabilities.
