EURALO Board Corner

We start this newsletter edition with the most discussed news from ICANN:

ICANN73 will convene as a Virtual Community Forum Meeting due to the continuing impacts of the COVID-19 pandemic. The resolution and full rationale from the ICANN Board of Directors can be found here. This Public Meeting was initially scheduled to be held in San Juan, Puerto Rico, from 5 to 10 March 2022. The ICANN73 Virtual Community Forum will take place in the Atlantic Standard Time zone (UTC -4) but the exact dates may change following consultation with ICANN community leadership.

Recognizing the importance of resuming in-person meetings as soon as it is practical to do so, the ICANN Board reaffirmed its intent to hold the ICANN74 Policy Forum, scheduled for June 2022 in The Hague, Netherlands, with in-person and virtual participation. In addition to its decision to convene ICANN73 as a virtual meeting, the Board has directed the ICANN President and Chief Executive Officer to coordinate with the ICANN community in designing ICANN74 as a hybrid meeting.

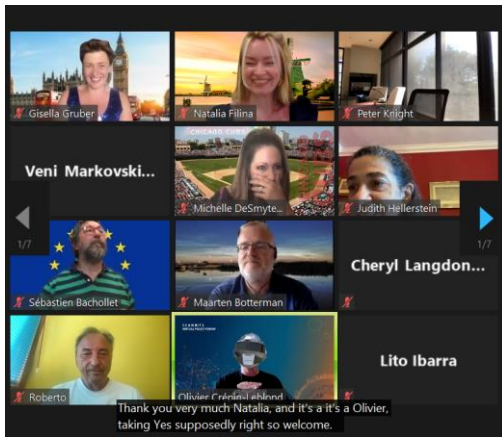

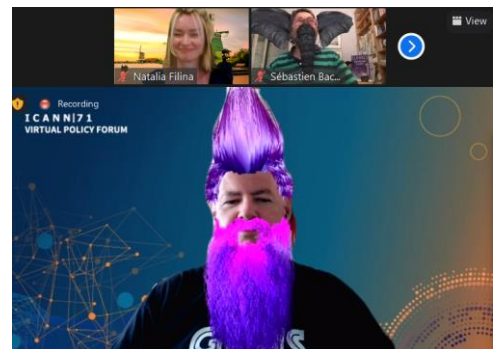

MEMBERS FOR THE 2021-2022 FBSC


A call for members for the 2021-2022 FBSC has been issued.

The primary task of the FBSC is the coordination of the annual Additional Budget Requests from the ALAC and the RALOs that will be submitted to be included in the FY23 ICANN budget.

From each RALO will be 2 members:

- One ALAC member to be selected by the region's ALAC members. Please note that Maureen, as advisor to the FBSC, would prefer not to serve as the APRALO ALAC member.
- One Member representing the RALO. This will normally be a RALO Chair, Vice-Chair (if the region has such an officer defined) or Secretariat. A RALO may choose someone else to be their official representative, as long as that person is both involved in the selection and preparation of that region's budget requests, and is empowered to act on behalf of the region on the FBSC.

By Wednesday, 10 November at 23:59 UTC the ALAC and EURALO members will be announced.

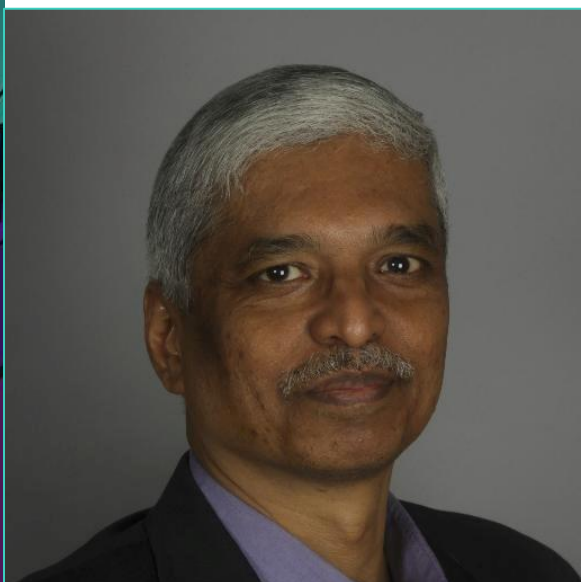

We cordially congratulate our friend and colleague on the well-deserved award!

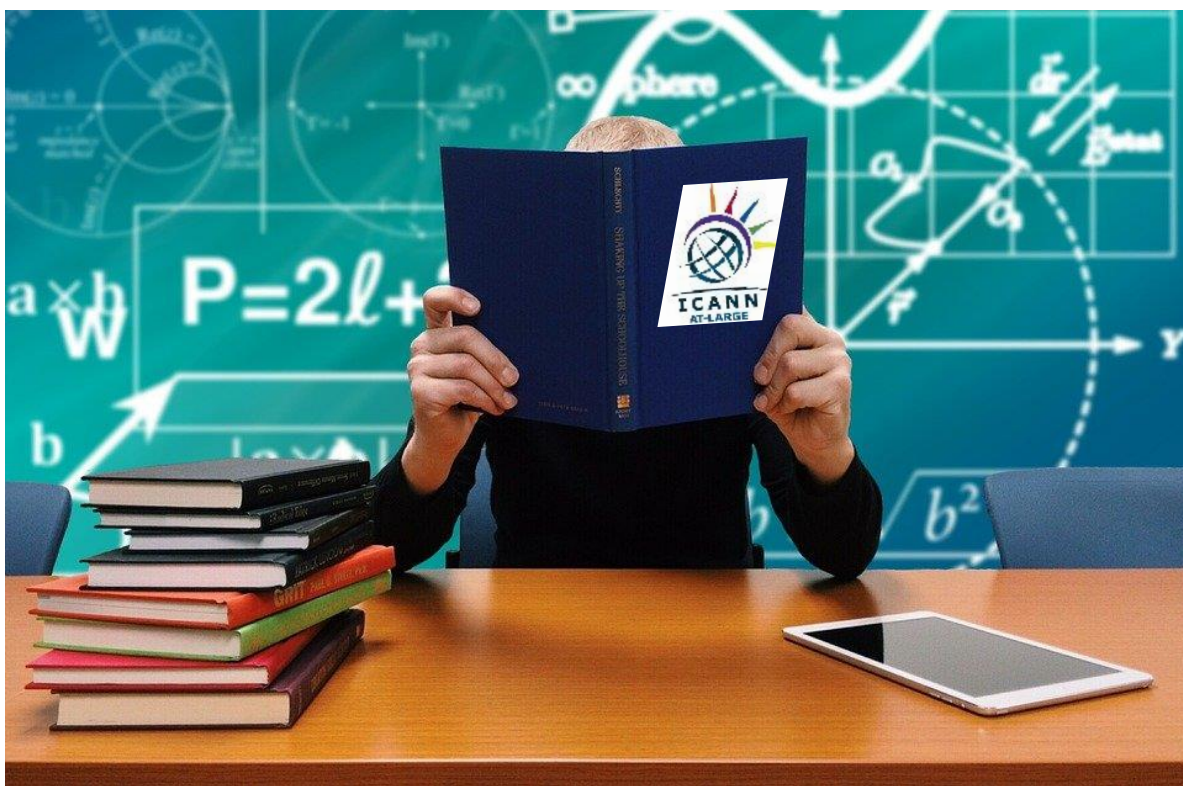

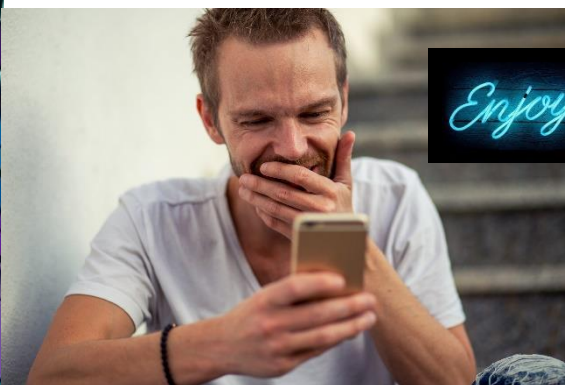
