

Key domains still not signed

- With more than half of all domain names secured with DNSSEC, it is a de-facto standard part of the product.
- Recommended standard for domain names registered by public administrative agencies in Norway - but they still lag behind (95% of domains are signed)
- And only 2 out of 10 of the high-traffic domains are signed

Status of top 10 high-traffic .no-domains November 2021





itself. The #EU's role is to lead initiatives that serve #citizens and users of the Internet,

Olivier Bringer, Head of [@NGI4eu](#) Unit ([@DigitalEU](#)): "We are very attached to multi-party governance of the # Internet, but we are not blissful admirers of it. It must be improved, by including more the #CivilSociety and smaller economic actors. "

We must cultivate the European model and its values, which it inspires, and organize partnerships aimed at converging on the issues of #DataProtection and # AI. The @EU_Commission does not have a monopoly on this. "
