
It's great to note that In the core of EURALO work we see the names of our new leaders and we would like to enhance this list of new activists.



Mate Master kindly provides us the summary of the discussion "Internet & Jurisdiction: Domain Names Issues":

Our 3 excellent speakers with their diverse background covered a huge range of important topics.

Mr. Bertrand de la Chapelle when speaking about DNS abuses,

- Broke down the topic to key components: DNS, abuses (putting an emphasis on real harm, the different types
 of abuses and the misleading nature of the word 'DNS abuse') and appropriateness (whether it is effective or
 legitimate).
 - We learned that in fact, it all boils down to when it is to act, and who and how should act.
 - On thresholds he highlighted the difference between technical abuses and content-related abuses
 - Stated that there are indeed situations where the action at DNS level is efficient and legitimate, albeit more frequently for technical abuses than content-related issues.
- · We touched upon the vast array of problems concerning roles and responsibilities, part of which Mr. Bertrand de la Chapelle emphasised the complexity of the ecosystem and workflow (which can lead to mistakes and inappropriateness).
- · I&Js (Internet and Jurisdiction)'s vision to enable collaboration and a safe space between stakeholders and their actual policy programs, including the short 2-3 pager outcomes that provide guidance and tools for stakeholders in relation to DNS abuses.
 - And his final message was to address abuses rather than just DNS abuse.
 - Ms. Uta Kohl gave us very important insights on public international law, stressing that jurisdictional rules are meta-rules
- The online regulatory environment in public international law, stressing that jurisdictional rules are meta-rules, in other words they can lay down who can act, on what and when.
- Touching upon the trends in internet jurisdiction, she highlighted that there wider regulatory expectations on a smaller group of global actors (prescriptive jurisdiction), while enforcement is becoming more important in preserving local law space.
 - Following that she listed the underlying shifts in substantive regulation, such as moving from information/content to data, considering the economic effect, and shifting to more proactive duties than reactive ones
 - · As for prescriptive jurisdiction on a small group of global platforms we saw recent examples of regulating harmful online content in Germany, France, UK, EU and Australia.
- The reason behind this that these companies have disproportionately large effects. However, the approach of focusing only on large players is somewhat contradictory to traditional concepts of law.
 - As for enforcement jurisdiction we saw examples of blocking and notice-and-takedown duties in the EU and data localisation regulation for example in the EU, the US and in Russia.
- · So what we see is a tit-for-tat game between states and platforms (in other words large corporations with access to a vast amount of data, in which access to lucrative markets more and more requires platforms to agree a gatekeeper responsibility, provide financial compensation and allow access to data by governments.



Mr. Dan B. Svantesson added that

Contrary to public international law, private international law is an unharmonized system that each country sets for themselves, in other words: a fragile system of conflict of laws.

Since the safety valve of the international recognition of enforcement we might see a sort of collapse of private international law due to international platforms.

ICANN choice of forum clause points to the US.

Jurisdiction in some cases is based on the location of a domain name.

· Private international law never played a big role in the context of harmonized rules. Contracts is a separate regulatory force, competitor to private international law (and law).

In this framework, platforms are doing too much and too little at the same time, so they are doomed to lose, which also leads us to the notion that the internet risks becoming the victim.

We also had questions from the audience, covering the area of the European Union's NIS2 proposal and e-Evidence regulation and their effect on DNS.

In the concluding remarks, Dan added that states are regaining power in the global scene, while Uta added that there are organizations over and above the state framework.

Bottom line transnational issues must be handled by transnational organizations.

We would like to thank our amazing Joanna Kulesza from ALAC and Sébastien Bachollet from EURALO played an essential role in organizing and moderating the roundtable.

ICANN Publishes FY21 Q2 Unaudited Financial Results

16 February 2021

ICANN published its unaudited financial results through the second quarter of fiscal year 2021. The ICANN financials are available here.

In addition, on 1 February 2021, Public Technical Identifiers (PTI) published its unaudited financial results through the second quarter of fiscal year 2021. The PTI financials are available here.

ICANN remains in a strong financial position despite the COVID-19 pandemic. Through December 2020, ICANN's actual funding is in line with prior years. Moreover, expenses have been lower than prior years primarily due to travel restrictions. Please see both sets of financials for more details.

ICANN and PTI publish quarterly financials in an effort to be transparent and accountable. The financial results have been published quarterly for many years but the accompanying announcement is a new measure meant to create more awareness of the results, which are usually posted 45 days after the quarter end.




