• Networking skills

Three years ago, my life changed completely. From being a lawyer from a small Balkan country, I started an interdisciplinary PhD, that involved an innovative way of looking at law by combining it with technology, another field very dear to my heart since teenage years. One of the best characteristics of this PhD programme is its high mobility structure, which requires spending one semester in each of the consortium universities. So, in 3 years, I spend at least 6 months conducting research in 6 universities around Europe, which gave me a unique networking opportunity. Besides this mobility, I involved myself in many other activities and conferences, starting with a winter school in cybersecurity organized by the DiploFoundation and DCAF. There I got introduced to the world of Internet Governance and heard about ICANN and EuroDIG for the first time. It attracted my attention so I participated at my first EuroDIG in 2016, both as part of an organizing team and as a flash session organizer on my own. From networking in this event, I learned about the ICANN NextGen programme, where I decided to apply and was successful. My first ICANN was one of the best networking opportunities that I have ever experienced, which opened the door to many other opportunities and long-lasting friendships.

• Mentoring/teaching experience

I started as a NextGen and then become a fellow, and then after understanding how important mentoring is for newcomers in the huge and complex ICANN environment, I decided to return as a NextGen Ambassador. And just a few days ago, I was promoted as a member of the Selection Committee for the NextGen program. As an academic, mentoring comes very natural to me and I enjoy it a lot. I have teaching experience since my high school years, when I held private courses for pupils, and was also giving extra classes of computer science to my high school students with the request of my professors. I have also worked as trainer at the Central Election Commission of Albania before starting my PhD.

• Project management skills

My project management and coordination skills are demonstrated from my work as National Academic Coordinator of the ELSA (European Law Students Association) Italy legal research group in preparing a research on the freedom of expression and the protection of journalistic sources for the Council of Europe; by my internship experience at the EU Info Center in Albania where I helped in the coordination of their projects; and by working for two years as member of the editorial board of the ELSA Law Journal. Now I am member of the organizing team of the first Albanian Youth IGF which will be held early in 2019.

• Written and communication skills

My written and verbal communication skills are demonstrated by my PhD research activities, my various publications and my presentations in various conferences around the world, with a main focus on IG, cybercrime, criminal justice and human rights.

• GNSO involvement

Lately I joined NCSG and NCUC and have been following all the discussions from the mailing list. I decided to first follow the discussions without being involved, in order to get a better understanding of how it functions from within. Now that I am done with my dissertation, I decided to start getting actively engaged in the policy development process and I think this mentoring opportunity will influence me in getting engaged in a better way, by learning from the eyes of new-coming and returning fellows and comparing with the experience of old members. My main aim is human rights policy development.

I am a member of NCSG and NCUC. I have participated in three ICANN Meetings, each time in a different position (NextGen, Fellow, NextGen Ambassador) which gave me a vast opportunity of looking at ICANN from different perspectives and understanding its mission, structure and multistakeholder model at its best. I have a two year experience in organizing sessions at the EuroDig conference, both as part of a team as well as individually, where I organized my own flash session at my very first EuroDig engagement. In June 2018 I was invited as a cybercrime expert at the Octopus Conference on Cybercrime from the Council of Europe. I am both member of youth groups as well as "grown-ups", forming a perfect bridge between the two. I am member of the organizing committee of the first Albanian YouthIGF, which will be held in early 2019, and I contribute also to the organization of the SEEDIG conference and occasionally to the SEE Monthly Summary. Currently, I am also leading the creation of ISOC Albania chapter which will influence in gathering the Albanian IG community in one platform and increase collaboration between stakeholders in the country. As a researcher from the University of Luxembourg, I am also conducting research on ICANN GDPR compliance process which will be published as a working paper.

As a lawyer and an interdisciplinary researcher, I was already familiar with the bottom-up multistakeholder model, but ICANN gave me the opportunity to see how it works from a closer look, by giving me the chance to be a part of it.

Mentoring is a responsibility which needs devotion, time and passion. This mentoring position came at the right moment in time for me, just when I handled my PhD dissertation, which means that now I have the necessary time to devote to this position both before and during the ICANN meetings since my workload is much reduced now. I think my abilities as a mentor within ICANN have been demonstrated already by my position as NexGen Ambassador, a mentor for the Nextgens, a position which I decided to accept despite having to submit my final dissertation just 5 days after the ICANN63 Meeting in Barcelona, by nevertheless devoting my time and resources to the NextGens both before and during the meeting. I loved mentoring the NextGens, and I would like to continue doing it, with time with the fellows, something which will lead me to see the differences and similarities between the same role in two programs and how can I influence in a higher networking between the nextgens and the fellows.

My teaching, training and presentation experience are proof of my ability to clear and consistent learning approaches. Together with my interdisciplinary studies, my research work at the intersection of law and technology, and my multicultural working experience prove my ability in presenting information in a simple and easy to understand manner for people coming from different professional and cultural backgrounds.

7. Please explain your interest in serving as a mentor and what you will bring to the Fellowship Program if selected.

I think a good mentor shares some common characteristics with a leader. They both help you grow by showing you all the right paths towards success, but at the same time, they give you enough freedom to decide on your own which path(s) you want to follow. Mentoring does not only mean having a clear and structured plan of action and following that plan with precision, it also means stopping to listen to your mentees requests and amending your plan accordingly.

I think one of the key things that a fellow needs is understanding the importance of networking and communication at the ICANN multistakeholder model, which is very different from networking in other conferences and events. Second key point is making them understand, believe and endorse the multistakeholder model and that no stakeholder is superior or dominant to the others in the ICANN policy making and in the IG ecosystem in general. Once they understand these two key issues, they will find getting engaged in ICANN much easy than thought at their first ICANN Meeting days when everything seems so complex and difficult to get through.

At my first ICANN Meeting, as a NextGen and newcomer, everything seemed so complex and I had a hard time figuring out how things work, since my ambassador was not very helpful in the process. At my second meeting, this time as a fellow, I had the chance of having a great coach, which made me understand how a good mentor, like a good teacher, could make your life easier at ICANN Meetings. I believe in the power of the fellowship programme in shaping the future leaders of the IG system and I believe in the importance of effective mentoring of new and also returning fellows towards this path, which leads me in wanting to become one of those mentors, who can one day proudly point at her "students" surpassing the "master".

Prior communication with the fellows is key to establishing a good relationship with the team and in providing them the first impressions of how their ICANN experience is going to be. I think a prior common online session with another team, would also help in both establishing better connections between the mentors, but also in creating a closer networking opportunity to the fellows and in giving them a good example of team work. It is important that regular communication is kept also during the meeting and create daily objectives to be achieved as a team and for each individual separately as well, by providing them advice on drafting their own daily agenda, not only for the session to follow but also for networking.

A good mentor at ICANN needs to have a working plan that fits both newcomers and returning fellows, be flexible and provide need-based individual advice adopted in accordance with each fellow's experience at ICANN and their background and level of expertise, help them network with other community members and keep in touch with them also after ICANN to help them figure out how can they get further engaged and contribute to the ICANN policy making.

This week I was appointed by Deborah Escalera as a member of the Selection Committee for the NextGen program for 2019/2020 rounds. I think having a role in both NextGen and fellowship during the same rounds is a very good opportunity into creating a much asked for bridge between the two programs, a concern which was highlighted by the fellows in the ICANN Fellowship Program Post-Meeting Report of ICANN63 and also by expressed by NextGens during ICANN63 in Barcelona. As an individual with experience from both the programs, I think I know better than any other the requirements of participants of these programs, therefore I make the right candidate for this mentoring position in helping them network, stay involved and create future collaborations with each other and with the other community members in a way that is productive for both the fellows and the community.
