## **Updates | July OEC Meeting**



#### **Update from the OEC discussion**

- The OEC had a constructive discussion at their 20 July meeting on Rebalancing proposal and participation.
- The OEC recognizes NomComRIWG work and the importance of these topics to the ICANN community. The OEC proposed that the Board engage with the SO/AC leadership in informal conversations on areas that will require Bylaws changes and will have far reaching governance implications.
- The expectation is that constructive dialogue would pave the way for the NomComRIWG proposals to be further socialized and advanced, considering their importance and impact.
- Informal engagement would occur before any formal steps are taken on modifying the Bylaws.
- The OEC confirmed that all proposed Bylaws amendments coming out of the NomComRIWG work will be packaged together, to make it easier for the community to understand the full scope of the proposals.
- ICANN org apprised the SO/AC leadership of the Board's interest in having such informal conversations in due course.
- The NomComRIWG proposal on Rebalancing of the NomCom would be the first topic of these conversations, possibly in September.
- The OEC supports and encourages the RIWG efforts toward re-engaging participants.
