#### **GUILTY OR INNOCENT?**

- Bill Cosby
  - Convicted of Sexual Assault
    - In part due to incriminating statements in a civil case
    - After DA (as sovereign) declined to prosecute
    - Successor of DA prosecuted anyway
  - Superior Court
    - Appeal Unsuccessful
  - Pennsylvania State Supreme Court
    - Appeal Successful
    - · Not referred back
  - Fundamental Fairness
- Miranda Warning
  - Procedural Fairness
    - Stop questioning after invocation

- Civil Law
  - Interprets statutes
  - Invalidation of statutues
- Common Law
  - Similar cases should have similar outcomes
  - Case Law
  - Authorities
    - Roman
    - Natural Justice
  - Interprets statutes
  - Binding (law) (creation)
- Legitimate Expectation

[...] an expectation of a benefit, relief or remedy that may ordinarily flow from a promise or established practice by administrative authorities.

#### **DUE PROCESS**

- US Constitution (5<sup>th</sup> & 14<sup>th</sup> Amendments)

  No person shall [...] shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law [...] nor shall any State deprive any person of life, liberty, or property, without due process of law.
- State Actors (Against Individuals)
- US Supreme Court
  - Substantial due process
  - Procedural due process
  - Incorporation of the Bill of Rights

### NATURAL JUSTICE (DUTY TO ACT FAIRLY)

- Originates in English Law
- Art 6 EU Convention on Human Rights
- Many Countries
  - Similar Protections
- Art 18 Namibian Constitution

  Administrative bodies and administrative officials shall act fairly and reasonably and comply with the requirements imposed upon such bodies and officials by common law and any relevant legislation [...]

### NATURAL JUSTICE (DUTY TO ACT FAIRLY)

- State and Administrative Actors
- Rule Against Bias
  - Nemo iudex in causa sua
  - Fundamental Fairness
    - Rational Decision Making
- Right To Fair Hearing
  - Audi alteram partem
  - Procedural Fairness
    - Notice
    - Opportunity to be heard
    - Legal Representation
    - Reasons
