**3. Type of work performed:**

I received the Ph.D. degree in computer engineering from the National Chiao-Tung University in 1984. From 1983 to 2009, I was on the faculty of the Department of Computer and Information Science at National Chiao-Tung University. From 1988 to 1991, I was the Director of the Computer Center at National Chiao-Tung University. From 1991 to 1992 and 1996 to 1998, I acted as the Chairman of Department of Computer and Information Science. From 1992 to 1996, I was the Director of the Computer Center at Ministry of Education and the Chairman of Taiwan Academic Network (TANet) management committee. From 1999 to 2003, I have participated in the National Telecommunication Project and acted as the Chairman of the Network Planning Committee, National Broadband Experimental Network (NBEN). From 2003 to 2006, I acted as the principal investigator of the Taiwan SIP/ENUM trial project and National IPv6 Deployment and Promotion project, and the Chairman of the SIP/ENUM Forum Taiwan. In Dec. 1999, I founded Taiwan Network Information Center (TWNIC) and was the Chairman of the board of directors of TWNIC from 1999 to 2005. I was also a science and technology consultant of Ministry of Education and the chair of the Cultivation Program of Information Technology Human Resource in Higher Education of Ministry of Education from 2001 to 2005 and was the Dean of the College of Computer Science, Asia University from 2005 to 2008. I was the recipient of the Excellent Achievement Award for Computer Technology made by the Ministry of Transportation and Communications in 2010. I am currently a vice president of ASIA University and the Chairman of the board of TWNIC.
