V. Standing Committee engagement with Bodies that appoint delegates to the NomCom

In fulfilling its purpose and responsibilities, the Standing Committee may provide guidance to appointing bodies on the diversity needs for the NomCom, in line with WS2 recommendations. Activities for this engagement may include:

- Providing clear materials and communication tools to support consistency
- Supporting the process Ensure a process is followed for replacing a new delegate to serve the remainder of the term due to vacancy or non-performance

Q: Do we want to clarify this is limited to their role as a liaison? Or is this intended to prevent anyone who served as an Associate Chair on the NomCom from ever sitting on the SC?
