Org support for Individual Groups in Implementing Remaining Recommendations

Org functions in support

Scope: Rec 6 (SOAC Accountability); remainder of Rec 1 following community decision on agreed Diversity elements

Next Steps

GNSO Council:

- Review staff-prepared initial inventory analysis (based on Council's [January 2020 Priority Level Assessment](#)); determine need for any further work and (if so) begin implementation planning
 - Guidelines for Good Faith (Rec 2): High
 - Framework of Interpretation of Human Rights (Rec 3): Medium to High
 - SOAC Accountability: Medium

GNSO SG/Cs:

- Complete initial inventory review; determine priority and timeline for additional implementation (if needed)

ICANN org:

- Update community on overall WS2 implementation status prior to ICANN72
- Continue to support community decisions and work on WS2 implementation:
 - Proposed ad hoc representative group (coordination of specific recommendations requiring community collaboration and prioritization)
 - Individual SO/AC/Groups
