Meeting Discussions:

Acceptance of notes from last meeting

Received request from Dr. Raymond Doctor to identify the person who discussed the ZWNJ/ZWJ issue during the 4 July call

Review of Action Items from last meeting

Akshat explained that they have a workshop going on right now in India regarding IDNs. The team in C-DAC will be responding to email messages on the Devanagari mailing list regarding the policy document around 15th of July.

Finish discussion of Draft Policy Document circulated by Dr. Kulkarni and answer any clarifications about the document that were later circulated later via email

Akshat asked for feedback on the definitions document

Mr. K.B Narayanan: Suggested:

1. Definitions: there should be a definition of terms used in this document (Akshat will take this action item)

2. Wanted to include on page P6. Of policy document regarding Mixing of scripts. Mixing of scripts at any level will not be allowed.

Andrew explained that technically, how can you restrict users from mixing scripts? Regardless of whether it is a ccTLD or a gTLD?

Akshat took the **action item for Akshat** to provide define terms used in the policy document.

Report structure to be used to create the issues report (current thinking)

Encourage the team to think about the variant issues report. Team members should start to think about and identify what are variant issues for the Devanagari script, such as:

1. What is a variant in the Devanagari script
2. How to represent variants formally (table related issues)
3. TLD vs. other level variants in Devanagari - what is applicable level wise
4. Variant TLD delegation
5. Variant TLD registration
6. Variant TLD resolution
7. Variants and user experience

Andrew Sullivan reminded everyone that what is essential for the report is to capture the issues that are most important to Devanagari. This is more important than the structure of the report or what may need to be in the report.

Review questions document (in preparation for creating the issues report, same document distributed in Singapore)

Questions document:

Steve Sheng explained that the goal is to stimulate discussion. As we contemplate setting up requirements for delegating variants, we should be thinking about the lifecycle of IDN variants: delegation and operation of

variant TLDs

Action Item for Steve Sheng: because of poor sound quality when Steve talked, the team could not hear his comments on the questions document. Steve Sheng will send his summary of the documents to the Devanagari mailing list shortly.

Action Item for the Devanagari team: read the Questions document.
