- As I am the last speaker of this 3rd At-Large policy session and this flash pitch tour to get the point of view of each Constituency regarding ICANN Accountability and Transparency and the ICANN Reviews I would like to thank
- We are all together able to have an overview of the community PoV regarding the future of ICANN reviews
- During the 2 years of the travels ban for ICANN participants some of the online sessions allowed a participation from across the ICANN community. It has proved to be useful to break the silos and to allow a better communication across communities to address a wide range of issues facing ICANN
- The At-Large/ALAC therefore supports the ATRT3 recommendation for a 'holistic review' that asks whether the structures put in place 20 years ago still best serve the whole community, or if changes in operations and structure will better achieve ICANN's objectives, including ensuring optimal representation of community views
- This recommendation from ATRT3 and proposed pilot from the Board are not included in the current ICANN budget
- At-Large/ALAC suggest to use (for the first time) the Supplemental Fund for Implementation of Community Recommendations (SFICR) to start as soon as possible a pilot for a holistic review, addressing the issues identified by ATRT3
- Last words regarding the continuous improvement program At-Large/ALAC is ready to start this new way to do the organizational review
