Reviews Multiyear Timeline (From ATRT3)





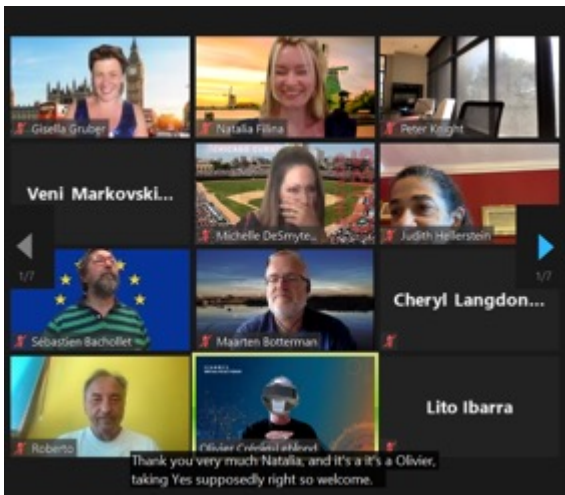

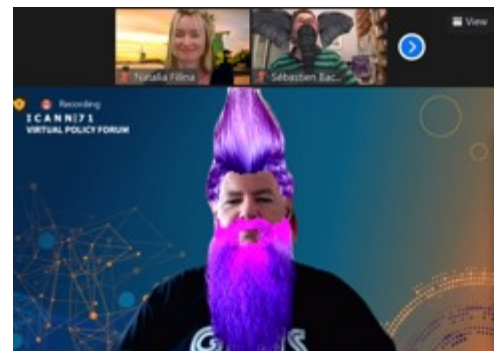

Looking at automated content moderation within platforms, it asks the questions of recommendable policy solutions to best address end user needs and concerns.
